father of two daughters and he due to his paucity of ~~found~~ intended to sale out the ~~some~~ 17 decimals of land of Mouza- Kutidih, alongwith a room and was in search of intending purchaser.

2. That as the complainant disclosed the fact of selling out of his land before Bhim Tewari son of Kishore Tewari and Ranjit Dubey son of Kishan Dubey both of ~~vill~~ are resident of Village + P.O.+ P.S.- Jhalda, who disclosed that Malhar Gulam Tahir S/o Gulam Mustafa of Village- Kantadih, Jhalda may purchase the land accordingly they along with complainant met with Malhar Gulam Tahir and the sale price was settled at Rs.17,000/- per decimals and the valuation of the land was settled at Rs. 2,04,000/- and it was further settled that as the room was constructed by the complainant Gulam Tahir pay further Rs. 35,000/- and the fact of sale was settled and the complainant disclosed that as the marriage of his daughter has been settled on 4th day of Ashar 1424 B.S.

At the time of oral agreement though Rs. 18,000/- was paid as advance but Bhim Tewari and Ranjit Dubey took Rs. 12,000/- from the complainant and the accused Tahir took the signature of the complainant in a blank Stamp Paper.

3. That though it was settled that the registration be completed on Magh 1423 B.S. and the complainant met with the accused Tahir number of occasion to get the

land to executed and registered and date was fixed 10th Magh 1423 B.S. and the complainant had been to Jhalda Sub-registry office but Gulam Tahir did not reach the registry office.

4. That thereafter number of occasion the complainant met with the Gulam Tahir but ~~the~~ reason best known to him neither he was interested to get the land ^{to} executed and registered and the marriage of the daughter was cancelled due to want of money.

5. That thereafter complainant ~~was~~ locked the room and at that time Tahir came to the disputed land and being informed by his man who resides near the room of the complainant and the accused Tahir immediately reached the place of occurrence and threatened the complainant by aiming a Pistol to shoot him if he ~~tries~~ to take possession of the room and land and he himself also locked the room by another lock.

6. That the complainant still then requested him to get the land registered but Tahir with ill-intention is not executing and registering the deed as there is a signed stamp paper in his possession of the complainant.

7. That on the basis of information lodged before O.C. Jhalda, accused Tahir was called at P.S. directed him to execute and register deed after paying the rest amount when he disclosed before the Police officer that very soon registration be made but when registration was not done

and as registration has not done further more accused Tahir aimed Pistol to the complainant to kill him if he tries to take possession of the room and land.

That the accused not only has ~~been~~ cheated but may have forged the Stamp Paper and also ^{trying to} caused ~~murder~~ ^{complainant} to the complainant for which the ~~provision~~ has been compelled to file this ^{Petition} ~~case~~ U/S- 156(3) Cr.P. Code before the Ld. Court for the punishment to him and his associates.

It is, therefore, prayed that your Honour be graciously pleased to pass an order to send this petition to the O.C. Jhalda, ^{P.S.} to get the facts of complain ^{investigated} and to submit report before the Ld. Court.
