

In preducing herewith the following arrested accd. persons (i) Santosh Saw (25) S/O- Lt. Ramu Saw at Jhalda Anandabazar Ward No-II, PS- Jhalda Dist- Purulia (ii) Ajit Dutta (45) S/O-Lt. Jhadu Dutta of Village-Tulin Machuwarpara, P.S- Jhalda, Dist.- Purulia and brought under seizure the following articles-(1) One Iron made "Bhojali" with wooden Butt, Total Length approx 12" (2) One Iron Rod Length about 2'5" breath 2 cm. approx after preparing a seizure list duly signed by the witnesses as well as aced, persons. I do hereby lodge a written complaint against the above noted accd. persons and others to the effect that on 16/08/2018 at 23:35 hrs received a telephonic information from my source that 9/10 criminals assembled by the infront of the Sub Register office Jhalda with a view to commit house dacoity in the Jhalda Town Area. After getting such type of information I noted the fact in G.D. vide Jhalda P.S GDE No- 587 Dt-16/08/2018 and informed the matter to I/C, Jhalda P.S. and as per his direction myself along with ASI. Biswajit Kalindi and accompany night Mobile officer and force ASI Mrinmay Choudhary, C/12 Gosta Bihari Mahato, C/497 Ambuj Mondal and C/ 958 Madhusudan Ojha proceeded towards the Sub Register office of Jhalda to work-out the said information with Govt. Vehicle No-WB 55/6183vide C.C. no- 2265/18. When myself along with accompanied officers and force reached near SI of School office Jhalda and stop the vehicle by the side of the road and proceeded to the Jhalda Sub Register office on foot and when we reached near the Jhalda Sub-Register office and found 9/10 persons sitting by the side of dark place and whispering each and others. We tried to apprehend them but seeing the police party they tried to flee away but on hot chase we able to apprehend the above noted 02 (Two) aced, persons. On immediate search on their person. One Iron made "Bhojali" with wooden Butt, recovered from Santosh Saw and One Iron rod from the right hand grip of accd. Ajit Dutta. On being asked they disclosed their identity as noted above and on interrogation they disclosed that (i) Sk. Imroj S/O Sk Yearmahammod of Kantadih, PS- Jhalda, Dist- Purulia (ii) Sk Saddam S/O Lt. Sk. Kumrul of village Tatari, PS-Purulia (M) A/P Kantadih, PS- Jhalda, (iii) Sk. Kalu S/O Sk Abul of village- Kantadih, PS-Jhalda, Dist-Purulia (iv) Sk Arsad S/O Sk Jinnat of village- Kantadih, PS- Jhalda, Dist-Purulia (v) Barun Kuiry S/O Biswanath Kuiry of village Mohonpur, PS- Kotshila, Dist- Purulia and 03 (Three) others who was unknown to them was their but they fled away on getting the scent of police. On being asked they could not give any satisfactory reason for keeping the, Bhojali and other weapons to assemble the place at the dead hour of night. On interrogation they also stated that they all assembled there to commit house dacoity in the Jhalda town area.

So, the 02 (Two) accd, persons was arrested after preparing arrest memo and seized the all above noted articles under proper seizure list duly signed by witnesses as well as the accd persons. Due to mid night hours no public witnesses was available there.

So I. therefore, lodged a complaint against accd. persons namely (i) Ajit Dutta S/O-Lt. Jhadu Dutta of Village-Tulin Machuwarpara, P.S- Jhalda, Dist.- Purulia (ii) Santosh Saw S/O-Lt. Ramu Saw at Jhalda Anandabazar Ward No-II, PS- Jhalda Dist- Purulia (iii) Sk. Imroj S/O Sk Yearmahammod of Kantadih, PS- Jhalda, Dist- Purulia (iv) Sk Saddam S/O Lt. Sk. Kumrul of village Tatari, PS- Purulia (M) A/P Kantadih, PS- Jhalda, (v) Sk. Kalu S/O Sk Abul of village-Kantadih, PS- Jhalda, Dist- Purulia (vi) Sk Arsad S/O Sk Jinnat of village-Kantadih, PS- Jhalda, Dist- Purulia (vii) Barun Kuiry S/O Biswanath Kuiry of village Mohonpur, PS- Kotshila, Dist-Purulia and 03 (Three) others for committing the offence U/S- 399/402 IPC.
