In producing herewith 1. One iron made improvised country made fire arms having butt body barrel approx lenghth 9.5 inchs and one round live ammunition. 2. one iron made improvised country made fire arms having butt body barrel approx lenghth 10 inchs and one round fired empty cartridge. 3. Two empty cartridges. 4. Four live cartridges 5. Thirty two numbers of lathi of different size 6. One hundred seventeen numbers of brick bats. 7. Eight numbers of iron rods. 8. Five numbers of tangis. 9. Some pieces of broken Glasses under proper seizer list to PS I, Shri Ranabir Kumar Bag I.C. Joypur PS do hereby lodged Suo motu complaint against (1) Aghori Gope of Jarroh P.S. Joypur(2) Sankar Narayan Singh Deo of Joypur P.S. Joypur (3) Piru Gope of Chhotka P.S. Joypur (4) Bapi Singh of Dimdiha P.S. Joypur and 700/800 unknown riotous mob to the fact that today (27.8.18) the date of board formation of Ghagra GP under Joypur PS was scheduled from 11.00 hrs. For that, order U/S 144 Cr.P.C. was promulgated by Shri Sandip Tudu, WBCS (Exe), SDO Jhalda vide order Sheet dated 24.8.18 with memo no 1260/1(5)/SDO/JLD dated-24.8.18.

At 8.15 hrs. S.I. Sunil Banerjee of Joypur PS along with JC/82 Kamal Dhal, JC/237 Pradip Choudhury, JC/50 Gour Chandra Rana, JC/514 Kamal Mahato, RJC/1508 Dinesh Kumar, NVF/620 Durjodhan Kumbhakar, RJC/1533 Chiranjit Mahato JC/335 Rabindranath Mahato, JLC/1151 Rina Garai., JLC /1100 Jaya Karmakar took departure for Ghagra GP office to perform duty in connection with formation of GP board. This has a reference vide Joypur PS GDE No 1195 dtd 27/08/18 and special C.C. No 147/18 dated 27/08/18. At 09.10 hrs myself along with constable 237 Gopinath Roy, RM 7301 Uday Joshi, RM 7480 Sanjib Pradhan, RM 7493 Ashis Bhujel and RM 7485 Arpan Pradhan left for Ghagra GP office vide Joypur PS GDE NO 1196 dated 27-08-18 and special CC No 148/18 after directing SI SK Ismail Ali, OC Baglata IC to remain present there with sufficient number of force & officer. At about 9.45 hrs. I reached at Ghagra GP office and found that about 250/350 people were assembled there. As order U/S 144 Cr.P.C. was in force, so I ordered them to disperse immediately .Saying this I engaged myself to supervise duty of police. At about 12:40 hrs. During process of formation of board the presiding officer Shri Arunava Patra, Co-operative Inspector Joypur Development Block .seized the caste certificate of Shri Adip Mondal, winning candidate of BJP. On seeing this the other winning candidates of BJP, FB, CPIM & Independent who were inside the room and taking part of this process conjointly became seriously violent and about to assault the presiding officer. Then the presiding officer requested me in writing to come to him inside the GP office to intervene into the matter .Accordingly I entered inside the office and tried to pacify the situation. In the meantime at about 14.00 hrs one Aghori Gope, an winning candidate of CPIM quickly came out from the GP office and instigated the BJP,FB, CPIM & Independent supporters, 700/800 in numbers who were assembled with lathi, tangi, and other deadly weapons, to attack police and TMC candidates those who were waiting outside the GP office and. On getting such instigation, the mob became very violent and started to attack police, other Govt. Officials and others with brick bats, lathi, tangi and other lethal weapons. Immediately myself along with other officers and force intervened into the matter and requested the mob to calm and cool but they did not pay any heed to my request and became more furious. Finding no other alternative I ordered them to disperse immediately but again they did not pay any heed and continuing their unlawful activities .Suddenly the said riotous mob pelting stones and assaulting us with lathi and other lethal weapons and some of them from riotous mob with a view to kill us opened fire indiscriminately from their illegal arms aiming towards police. Then & there I warned them that we are equipped with gas gun and fire arms and we will use the said gas gun and fire arms if they do not disperse immediately. But the unruly mob ignored my warning and continuing their unlawful activities like brick batting and firing from illegal fire arms. Due to their illegal activities RM 6663 Nakul gurung of EFR 1st Bn Salua now camping at Baglata IC under Joypur PS and sustained severe injuries on his head and fell down on the ground in front of Ghagra GP Office.SI Sk Ismail Ali, OC Baglata IC, Habildar1641 Chandra Kumar Magar, RM 1461 Chakra Bikramsahi & RM 1525 Bikash Magar all of EFR 3rd BN Salua also

got injury in their person during the process. Finally in order to disperse the unruly mob I ordered C/237 Gopinath Roy to open Gas

fire from his gas gun. Accordingly he fired 7 rounds TS Cell from his gas gun but the unruly mob did not disperse and became seriously furious and started ransacking our Govt vehicles bearing Registration WB 56J/3748 with lathi, iron rods etc.. Finding no other alternative to disperse the unruly mob I ordered RM 7480 Sanjib Pradhan of A Coy 1st Bn EFR to fire two rounds from his INSAS Rifle in open air. Accordingly RM 7480 Saniib Pradhan fired two (2) rds. from his INSAS Rifle in open air. After that the unruly mob became furious like anything and chased us saying "SALA SOURER BACHHA POLICEDER MERE SESH KORE DE" as we were less in number and we took shelter in the office room of Ghagra GP with all injured police personnel. Then & there at about 14:15 hrs we sought for reinforcement from District Headquarter Purulia over mobile phone. We remained inside the Ghagra GP Office till the arrival of the reinforcement from Purulia at 15:25 hrs. Till then the unruly mob encircled us from all sides. At about 15: 25 hrs the reinforcement arrived from District headquarter and we came out from Ghagra GP Office and found that one unknown male person aged about 30 yrs was found lying by the side of Ghagra High School adjacent to the Ghagra GP office in injured condition. Considering the seriousness of the injuries I made arrangement to shift the unknown male person and the RM 6663 Nakul Gurung to Purulia Deben Mahato Sadar hospital and the rest injured police personal to Joypur BPHC. Finally on seeing the large number of police, the unruly mob dispersed from the spot. During the search of the Place of occurrence, the following articles were found & seized under proper seizure list duly signed by the witnesses- 1.one iron made improvised country made fire arms having butt body barrel approx length 9.5 inchs and one round live ammunition. 2. one iron made improvised country made fire arms having butt body barrel approx lenghth 10 inchs and one round fired empty cartridge. 3. Two empty cartridges. 4. Four live cartridges 5. Thirty two numbers of lathi of different size 6. One hundred seventeen numbers of brick bats. 7. Eight numbers of iron rods. 8. Five numbers of tangis. 9. Some pieces of broken Glasses.

During enquiry I came to know that to restrain the TMC candidates from taking part in the process of the board formation the local BJP, FB & CPIM leaders conjointly under the leadership of 1.Aghori Gope of Jorre, 2. Shankar Narayan Sing Deo of Joypur, 3 Piru Gope of Chhatka, & Bapi Sing of Dimdiha accumulated huge number of persons from Ghagra village and its adjoining areas as well as Jharkhand States, as the border of Jharkhand is located within 3 KM from the PO. Message of this incident is being sent to DM Purulia.

So I registered Joypur PS Case No 68/18 dtd 27/08/18 U/S 147/148/149/186/188/324/325/332/333/353/427/307 IPC r/w 3 / 4 PDPP Act & 25/27 Arms Act against (1) Aghori Gope of Jarroh P.S. Joypur (2) Sankar Narayan Singh Deo of Joypur P.S. Joypur (3) Piru Gope of Chhotka P.S. Joypur (4) Bapi Singh of Dimdiha P.S. Joypur and 700/800 others as suo-moto and directed SI Jayanta Kumar Chakraborty of Joypur PS for its investigation.
