Entered the premises of Sri Durgadas Murmu S/O LT. Sagar Majhi, and found that he is consuming electricity dishonestly by means of broken of seal from terminal cover and insert a small piece of wire at incoming side to resist actual consumption of meter. The consumer id 242036707.

Total Load found approx 0.2 KW (fan-1 no, , CFL-2 no)

Then we disconnect his permanent connection and seized the following articles.

- 1)Energy Meter No-0175640 make-TGL. Fitted with fibre board .
- 2)MCB-1 NO. with one Cut OUT, 5 Amp. (Female portion) fitted with wooden board...

After preparation of proper seizure list The seizure list are prepared at the site and the representative of accused person refuse to sign in the seizer list. The inspection team left the above premises at about 02.35. pm. The accused person has committed an offence U/S-135(i)(a)(b) of the Electricity (Amendment) Act-2007 for illegal theft of electricity.
