Respected Sir,

In producing herewith one arrested accused namely Raju Chowdhury (30), S/O - Musur @ Manu Chowdhury of village-Indrabil Minibazar, PS- Kashipur, Dist- Purulia along with seized articles, I beg to report that on 19.08.18 at about 17.35 hrs in course of mobile duty myself along with force got reliable source information that one person is selling country liquor at village Indrabil Mini Bazar, in his house. Accordingly myself along with C/559 Tarani Majee and JC/977 Tarun Kadam both of Kashipur P.S reached at Indrabil Mini Bazar at about 18.35 hrs and found that one person was selling C.S.liquor in his house. After seeing police party liquor customers fled away from the spot. On demand the seller failed to produce any valid document for selling C.S. liquor in his possession. So the above noted accused has committed an offence U/S -46(A)(c) B.E. Act 1909 Amended up-to date. During search I found (1) 25 (Twenty five) sealed bottles(Plastick) of DILKHUSH C.S. liquor (600 ml each) (2) 05(Five) empty Plastick bottles of DILKHUSH C.S. (3) 04 (Four) Plastic Tea Glass (4) Rs. 20+20+10+10+10+10+10+5 = 95/- (Ninety five) as sale proceed, accordingly I seized the above noted articles under proper seizure list duly signed by the witnesses in between 18.45 hrs. to 19:05 hrs. I also seized and labeled bottles with sample C.S. liquor at the spot in presence of accused person and witnesses. Accordingly I arrested the above noted accused person U/S- 67 Bengal Excise Act 1909 and informing him the ground of arrest and I prepared arrest memo after maintaining all arresting rule as well as I brought him to P.S. with seized above noted articles.

Therefore I pray before you that kindly arrange to start a specific case under proper section of law U/S 46(A)(c) B.E. Act 1909 against arrested accused namely Raju Chowdhury (30), S/O - Musur @ Manu Chowdhury of village-Indrabil Minibazar, PS- Kashipur, Dist- Purulia and arrange for its investigation.
