I do hereby lodge a complaint empowered by enabling the Electricity act 2003 subsequently Electricity (Amendment) Act-2007 to the effect that Sri Karnadeb Mondal s/o Lt. Bibhuti Bhusan Mondal, Vill +PO- Kustore, Dist-PURULIA has committed theft of Electricity U/S-135(1)(a) of the Electricity Act 2003, (Amendment) Act-2007.

On dated 23.08.2018 I received a secret complain over telephone Sri Karnadeb Mondal s/o Lt. Bibhuti Bhusan Mondal, Vill +PO- Kustore, Dist-PURULIA consuming electricity for his commercial shop by means of hooking from nearest It network of WBSEDCL.

On the basis of said complaint at about 12.20 pm. I, Sri Mrinal Chowdhury, Assistant Engineer & Station Manager Kashipur Customer Care Centre, WBSEDCL along with,

- 1) Sri Dipak Kr. Bhowmik, SAE, Kashipur CCC
- 3) Sri Debraj Roy OE Kashipur CCC.

Entered the premises of Sri Karnadeb Mondal, and found that he is consuming electricity dishonestly by means of hooking for his commercial shop though there is other service connection entitled. his con id-242074716.

Total Load found approx 0.4 KW (Zerox-1, fan-1 no, cfl-1, computer-1)

Then we disconnect his permanent connection and seized the following articles.

1. Hooking device with PVC Wire-15 Feet (approx)
2. Bulb With Holder-1 no.

After preparation of proper seizure list The seizure list are prepared at the site and the representative of accused person refuse to sign in the seizer list. The inspection team left the above premises at about 01.05 pm. The accused person has committed an offence U/S-135(i)(a) of the Electricity (Amendment) Act-2007 for illegal theft of electricity.

You are requested to take cognizance of the complaint and treat it as F.I.R and action may be taken as per rule.
