I do hereby lodge a complaint empowered by amending the Electricity act 2003 subsequently Electricity (Amendment) Act-2007 to the effect that Elisab Singh Sonder S/O Khagan Singh Sonder of village Harmoni P.O. Harmoni P.S. Mambazari Dist - Purulia, has committed theft of Electricity U/S 135(1)(a) of the Electricity (Amendment) Act-2007.
