
1... That the Complainant and accused person are


Plot No. 3525 over which he made some construction like some temporary rooms & roofs and that he also surrounded the plot by placing cement pillar and by wire having one entrance gate. The Complainant also runs coaching classes, for the poor students and also have one Arcastar team and also attached with so many social activities. The Complainant has a flower garden, vegetable garden and also planted so many valuable trees over the said land.

2... That he has his residential house to the extreme eastern portion adjacent to South of the said plot.

3... That such activities of the Complainant having his good name of the locality accused person bore grudge against him and the accused person always trying to do mischief in the said land so that those activities of the complainant be stopped. The accused person with some ill-intention kept an opening so that he could reach the said land of the complainant.

4... That on 26.5.18. at 5.15 P.M. the accused person very cleverly all on a sudden criminally trespassed in to the land of the complainant by breaking open the fencing and a pillar and loss of Rs. 5,000/- (Rupees Five thousand)

and thereafter the accused person has damaged the flower garden, vegetables garden and some trees causing loss of Rs.2,000/- (Rupees Two thousand).

When the Complainant protested then the accused person abused him filthy languages and also assaulted him with fist and blows and threatened him with dire consequences and there was some hot altercation in between the parties and there is such noise the local people and as well as the witnesses collected there then the accused person left the place after taking one spade, one pick axe, and one spray machine belongs to the complainant. The value of those articles is Rs.14,000/- (Rupees Fourteen thousand)

5... That the Complainant informed the matter to the local Police Station and thereafter the superintendent of Police, Purulia but no such legal action has been taken for that the Complainant is compelled to file this complaint before the Ld. Court under the law.

6... That the accused person has committed various offences under the penal act for which he is deserved to be punished under the law.
