Dear Sir,

I do hereby lodge a complaint empowered by enabling the Electricity Act 2003 subsequently Electricity (Amendment) Act-2007 to the effect that Sri Gurupada Basu S/O Uttam Basu of Village- Gobindanagar, P.O. Pialsole, P.S. Mambazar, Dist - Purulia, has committed theft of Electricity U/S 135(1)(a) of the Electricity (Amendment) Act-2007.

On dated 13.08.18 at about 06:10 AM, Sri Swarup Mandal, Station Manager, Mambazar Customer Care Centre, WBSEDCL along with,

- 1) Sri Pradip Choudhury, DE & DM, Raghunathpur Division, WBSEDCL
- 2) Sri Mrityunjay Mondal, SAE(E) Mambazar CCC
- 3) Santu Dhal, SAE (E) Mambazar CCC

entered the premises of Sri Gurupada Basu, S/O Uttam Basu of Village- Gobindanagar, P.O. Pialsole, P.S. Mambazar, Dist - Purulia and inspected his/her premises and found that he was enjoying electricity unauthorisely by direct hooking from nearest WBSEDCL's LT line

During inspection, theft of electricity was found, i.e., he/she was using electricity dishonestly U/S 135(1)(a) was detected. It was also found that he/she was using the following electrical equipments -

- 1) One No. 100 watt bulb
- 2) one No. Ceiling Fan 60² watt
- 3) one No. CFL bulb 20 watt
- 4) Two No. LED bulb 10 watt each.

out of which we seized the following -

- 1) one No. 100 watt bulb
- 2) 10 mtrs (approx) single core P.V.C wire along with hooking device
- 3)

The seizure list is prepared at the site and the accused person refused to sign in the seizure list. The inspection team left the above premises at about 06:21 PM on dated 13.08.18. The accused person has committed an offence U/S 135(1)(a) of the Electricity (Amendment) Act-2007.

You are requested to take cognizance of the complaint and treat it as F.I.R. and action may be taken as per rule.
