Dear Sir,

I do hereby lodge a complaint empowered by enabling the Electricity act 2003 subsequently Electricity (Amendment) Act-2007 to the effect that Jagad Bauri S/O Lt. Bhramar Bauri of Village-Gobindanagar, P.O-Palsol P.S. Manbazar, Dist - Purulia, has committed theft of Electricity U/S 135(1)(a) of the Electricity (Amendment) Act-2007.

On dated 13/08/18 at about 6:27 PM, Sri Swarnp Mandal, Station Manager, Manbazar Customer Care Centre, WBSEDCL along with,

- 1) Pradip Chowdhury, DE & DM, Raghunathpur (D) Division, WBSEDCL
- 2) Mrityungay Mandal, SAE (E), Manbazar CCC
- 3) Santu Dhati, SAE, Manbazar CCC

entered the premises of Jagad Bauri, S/O Lt. Bhramar Bauri of Village-Gobindanagar, P.O-Palsol, P.S.-Manbazar, Dist-Purulia and inspected his/her premises and found that he was using electricity unauthorisly by direct hooking from WBSEDCL LTCH system.

During inspection, theft of electricity was found, i.e., he/she was using electricity dishonestly U/S 135(1)(a) was detected. It was also found that he/she was using the following electrical equipments -

- 1) 1 (one) 100 Watt Lamp
- 2) 1 (one) 40 watt Lamp
- 3) 1 (one) 60 watt fan
- 4)

out of which we seized the following -

- 1) 1 (one) 100 Watt Lamp
- 2) 15 mtr flexible single core PVC wire with hooking device.

The seizure list is prepared at the site and the accused person refused to sign in the seizure list. The inspection team left the above premises at about 6:27 PM on dated 13/08/18. The accused person has committed an offence U/S 135(1)(a) of the Electricity (Amendment) Act-2007.

You are requested to take cognizance of the complaint and treat it as F.I.R. and action may be taken as per rule.
