Dear Sir,

I do hereby lodge a complaint empowered by enabling the Electricity act 2003 subsequently Electricity (Amendment) Act-2007 to the effect that Dharu Bauri S/O late Sarbani Bauri of Village Gobindanagar, P.O. Piarsal, P.S. Manbazar, Dist - Purulia, has committed theft of Electricity U/S 135(1)(a) of the Electricity (Amendment) Act-2007.

On dated 13/08/2018 at about 6.28 pm, Sri Swarnp Mandal, Station Manager, Manbazar Customer Care Centre, WBSEDCL along with,

entered the premises of Dharu Bauri S/O late Sarbani Bauri of Village Gobindanagar, P.O. Manbazar, Dist - Purulia and inspected his/her premises, and found that he was using electricity unlawfully by direct hooking from WBSEDCL LT OH system.

During inspection, theft of electricity was found, i.e., he/she was using electricity dishonestly U/S 135(1)(a) was detected. It was also found that he/she was using the following electrical equipments -
