Sub: Prayer for starting a specific case under proper section of law.

Sir.

In producing herewith one seized truck bearing no -WB 37C/5489 loaded with raw coal of 10 M.T. (approx) do hereby lodge a complaint to the effect that on (31/07/18) myself along with C/66 Kameshwar Pandey and C/1224 Gajan Murmu all of Neturia PS were engaged in night mobile duty vide Neturia PS GDE No- 1516 Dt. 31.07.18 & CC No- 2450/18 Dt. 31.07.18. In course of night Mobile Duty, at about 22:15 hrs when we reached at Gobag More, I received an credible source information to the effect that one truck bearing no WB 37C/5489 loaded with illegal coal coming from Asansol side to Raghunathpur side and will transport the same to Raghunathpur side in clandestine manner as per their regular practice. I immediately intimated to you over phone and acquainted you about the information and you directed me to work out the information. As per your direction I along with force immediately started to move towards Bhamuria More through Purulia - Barakar pitch road at 22.25 hours. At about 22.45 hrs we reached at Bhamuria More on Purulia - Barakar pitch road under Neturia PS and started naka checking there to intercept the vehicle. During naka checking we found that one truck which was coming from Asansol side suddenly stopped about 70/80 meter away from us and one person seems to be the driver of the vehicle got down from the vehicle and started running towards dark side beside the road. We chased the person but in spite of hot chase he managed to flee away. We searched the surrounding are with torch light to find out the person but failed to trace out him. On search we found that the truck having Regd. no - WB 37C/5489 was loaded with raw coal of 10 M.T. (approx) and the key of the truck has been left away in the truck by the driver.

So, there is reason to believe that the driver and registered owner of the said vehicle have collected the said coal either by theft or by any fraudulent means and tried to dispose of the same coal in a clandestine manner to Raghunathpur side knowing it to be stolen, as per their regular practice.

Accordingly I seized the said truck bearing no – WB 37C/5489 loaded with raw coal of 10 M.T. (approx) under proper seizure list duly signed by the Police witnesses in between 23.45 hrs and 23.55 hrs, since no public witness was found.

Under the above circumstances a specific case may kindly be started against the 1) driver and 2) Registered owner of truck bearing no – WB 37C/5489 under proper section of law.
