Saltore Customer Care Centre, WBSEDCL do hereby lodge Complaint against  
Shantimoy Mukherjee aged about 52 yrs son of Lt Chandicharan  
Mukherjee of vill - Ranapur PS - Neltoria Dist - Purnia vide Commer  
Id - 201230327 to the effect that on today (04-08-2018) round  
about - 08:40 hrs myself along with (1) Sri Pradip Choudhury, Divisional -  
Manager, Raghunathpur Division, (2) Sri Surman Banerjee, Sr. SAE of -  
Raghunathpur Division (3) Sri Goutamoy Dass, SAE (E) (4) Sri Gouram Kishorey  
of Saltore Customer Care Centre had been in the home of Sri Shantimoy Mukher-  
jee for inspection. Prior inspection a notice was served on Sri  
Shantimoy Mukherjee duly received by him.

A thorough inspection was conducted by me assisted by  
the Divisional Manager Sri Pradip Choudhury. During physical  
inspection it was found that the incoming service cable was cut  
and one parallel connection has been made from the cutting point.  
The other end of the parallel connection with two core pvc cable  
has been connected to the main switch situated/ fixed on the  
inside of the room. From the above arrangement Sri Mukherjee  
was used to connect electricity to run the electrical gadgets of  
the house by passing the electric meter and without reflection of  
consumption in the meter. The total load found is 2.836 KW. This is  
a clear theft of electricity and Sri Mukherjee is liable for prosecu-  
tion under section 135(I)(b) of the IE Act 2003 amended on 2007.
