Sir,

With due respect & humble submission I, Dipali Mondal W/O- Late Dilip Mondal, a resident of Sangamohul, Khokrapahari, Mugma, PS- Nirsha, Dist-Dhanbad, Jharkhand would like to inform you that on 02.08.18 morning my husband Dilip Mondal along with my nephew Ramu Mondal S/O- Mahadeo Mondal were returning to home from their work place by a motorcycle bearing No- JH 10 AQ/8618. On way at Inanpur they were filing air in the said motorcycle at the garage of Sk. Nasim. At around 07:00 hrs one truck bearing No- WB 39A/5811 which was coming from Asansol side & heading towards Raghunathpur, dashed my husband & nephew. Resulted in both sustained grievous injuries on their persons, locals shifted them to nearest health center "Harmaddih CHC" where the attending MO declared them as brought dead. Moreover the accident took place due to rough & negligence driving on the part of the driver of the said offending vehicle. The place being populated, the driver drove the vehicle intentionally with very high speed. Due to said accident the garage also got heavily damaged. On the other hand the motorcycle having No- JH 10 AQ/8618 also got badly damaged. As per the locals, the driver had full knowledge of the road & its vehicular movement then also, with an ill intention he drove the offending vehicle in such a manner that two lives got ruined.

Under the above circumstances I pray before your good self that a specific case may kindly be initiated against the driver of the offending vehicle bearing no WB 39A 5811.
