(08-08-2018) Sri Niranjan Barui s/o - Bagharbar Barui of vill.
Moupmra PS - Neturia Dist - Purnia was enjoying electricity un-
authorisedly by means of direct hooking from nearest LTHT of
WBSEDCL and due to this reason he has committed theft of electricity
yps-135(1)(a) of the Electricity act 2003 amended on-2007.

On (08-08-2018) at about 15:10 Hrs I, Bibhas Barui, s/o Dilip
Kr Barui, Station Manager Satore Customer Care Centre along with Sri
Goutam Das, SAE (E) (2) Sri Goutam Kr Family, HTSHT had been at
Moupmra village for deemed disconnection premises visit. During such
inspection it was noticed one single core hooking device with
single core PVC cable has been connected to the LTHT line
of WBSEDCL and upon following the said cable it was found
the other end of the cable is connected to the ~~house~~
internal wiring of of Sri Niranjan Barui as local people
informed and upon enquiry of the identity of the said people
they refused to divulge their identity. After that one middle
aged person claiming himself as Bagharbar Barui father of
Niranjan Barui came outside. ~~He~~ Conducted through impulsion

After impetion of the arrangement it has been cleared that Sh. Niranjam Bami s/o - Baghambar Bami was enjoying electricity dishonestly by drawing illegal hooking from the nearest LTOT of WBS EDC, i.e 135(1)(a) detected.

From the arrangement he was using the following equipments viz ① Electric Bulb - 01 no (100w) ② Electric Fan - 01 no (60w). Total load found was - 0.160 kw.

From the arrangement I seized the following:-

- ① Single Core PVC Cable with hooking device attached size of length 40 feet approx.
- ② Electric Bulb with holder - 100 watt.

Seizure list was prepared at the site and the representative of accused person refused to sign on it.

The impetion team left the premises on - 08/8/2018 at about 15:35 Hrs.

In this context it has been also observed from available office record that the ~~accused~~ there was one connection against Connor id - 242034989 and the said connection was disconnected due to ~~out~~ outstanding dues or non payment of energy bill, of rupees - 866 on 08/8/18.

The accused person has committed an offence u/s - 135(1)(a) of the Electricity Act 2003 duly amended on 2007.

You are requested to take cognizance of the complaint and treat it as FIR and action may be taken as per rule. I handed to you impetion report, seizure list, all in original and seized article as per seizure list for further necessary action.
