Respected Sir,

In producing herewith one accd. Person namely Sudhir Mondal (60) S/O- Lt. Khandu Mondal of village Raibandh, PS-Neturia, District- Purulia with seizure of (1) 05 pcs. Sealed bottles of Officer Choice containing 180 ml. each (2) 03 pcs. Sealed bottles of Rum containing 180 ml. each (3) 10 pcs. Sealed bottles of Dil Diamond country spirit containing 600 ml. each (4) 05 pcs. Sealed bottles of Dil Diamond country spirit containing 300 ml. each, which were seized under proper seizure list.

I beg to submit that today (12.08.18) in between 18.35 hrs to 19.35 hrs. a raid was conducted in the shop of Sudhir Mondal (60) S/O- Lt. Khandu Mondal of village Raibandh, PS-Neturia, District- Purulia which is attached with his house situated at Raibandh village under PS Neturia on acting of a secret source information against illegal stock and selling of liquor of the above noted anticipated place and found that the above noted person was keeping / selling liquor which were kept in his shop on demand Sudhir Mondal failed to produce any valid documentary authority in respect of selling of liquor as well as nobody turned up to produce any valid documents . As such he committed offence u/s 46 A(c) B.E. Act and he was arrested U/S-67 BE Act and also (1) 05 pcs. Sealed bottles of Officer Choice containing 180 ml. each (2) 03 pcs. Sealed bottles of Rum containing 180 ml. each (3) 10 pcs. Sealed bottles of Dil Diamond country spirit containing 600 ml. each (4) 05 pcs. Sealed bottles of Dil Diamond country spirit containing 300 ml. each which were seized under proper seizure list duly signed by witnesses and labeled at the time of arrest. During arrest the ground of arrest was duly notified, issuing arrest memo u/s 50 Cr.P.C. and handed a copy of the same to arrestee.

The arrested accd. namely Sudhir Mondal (60) S/O- Lt. Khandu Mondal of village Raibandh, PS-Neturia, District- Purulia has committed offence u/s 46 A(c) B.E. Act, 1909 for unauthorized possession and sale of liquor.

It may note here that during raid 1. C/278 Ashok Chandra, 2. C/470 Somnath Nag & 3. C/382 Bipad Taran Chattarjee all of Neturia PS accompanied me.

Under the fact and circumstances I therefore pray that a specific case may kindly be started against Sudhir Mondal (60) S/O- Lt. Khandu Mondal of village Raibandh, PS-Neturia, District- Purulia under proper section of law.
