With due respect, I, Satish Kumar Shaw, son of Gangaonar Shaw, resident of Parbelia Bus Stand, Post & P.S. Neturia, District: Purulia would beg to inform you that on 20.08.2018 at about 8:15 A.M., my daughter Madhu Shaw (21 years), had been to Asansol Girls' College to collect her BCA Final year mark sheet. Since, then she had gone missing and inspite of our strenuous efforts we could not trace her whereabouts. I had informed the matter to the Cop of Neturia P.S. and they had diarized the matter vide G.D.E. Number 962 dated 21.08.18.

Today i.e. on 22.08.2018 at about 12:29 p.m., a call came on my wife's number (+916296219340) from an unknown number (+919082336952) and informed her with the utterance "MADHU MERE PASS HAI AAPKO JO KARNA HAI KAR LO". Be it mentioned that my daughter had solemnised her marriage with one Rajan Kumar Mandal, son of Manoj Mandal of Parbelia Railway Crossing, Post & P.S. Neturia, District: Purulia on 26.03.2018 before the Marriage Officer, Bijaynand Singh of Kulti. After, passage of a formidable time my daughter realized her mistake and had filed a case for annulling her marriage being Mat Suit No. 11741/2018, u/s 25(i) of Special Marriage Act on 30.07.2018 pending before the Ld. Special Court at Asansol.

Panick stricken I am apprehending that my daugher has fallen prey to the rapacious desire of said Rajan Kumar Mandal, his father Manoj Mandal (father name unknown), and his uncle Ramesh Kumar Mandal (father name unknown) who under criminal conspiracy have abducted my daughter forcefully against her will. I, with folded hands do pray before your good office to recover my daughter before she meets some unfortunate consequences. Hope you will look into the matter at the earliest and do the needful at the earliest to ensure the "Right to Life" of my unfortunate daughter as guaranteed in our Constitution.
