at Nadiha village for zero unit Consumption checking. During
that work we entered one Premises at Sri Nirmal Karmakar
for inspection as per our List of office record. Prior inspection
one notice was served upon Sri Karmakar duly received by
him.

During inspection it has been observed that Nirmal
Karmakar s/o - Sunil Karmakar has been enjoying electricity by
means of tapping from incoming terminal of the meter and
destroying/cutting the security seal and without reflecting the
actual energy consumption in the energy meter. From the
arrangement he was enjoying the following equipments viz:-
(1) Bulb - 100 watt (02 nos) (2) Stand fan - 180W (01 no) (3) High Speed fan - 60W
(01 no) (4) Ceiling fan - 80 watt (01 no) (5) T.V. - 70W (01 no) (6) LED bulb
09 watt (01 no).

The Total load found was 0.617 kW. This is a clear theft of electricity and Sri Karmakar is liable for prosecution under Section 135-
(1)(b) of the Indian Electricity Act 2003 duly amended on 2007. The Service Connection has been disconnected from pole side.

I Seized the following articles as per proper Seizure List and the accused refused to sign on the Seizure List.

Article Seized:-

- ① Single phase Energy meter bearing SL NO - BR376444 with a portion of incoming service cable and tapping point with outgoing cable connected to a main switch of length (4) four feet approx.
