I do hereby lodge a complaint empowered by enabling the Electricity act 2003 subsequently Electricity (Amendment) Act-2007 to the effect that Sri Mantu Bowri S/O- Late Haku Bowri of Village- Anara, P.O- Anara(BO), P.S- Para, Dist-PURULIA has committed theft of Electricity U/S-135 of the Electricity (Amendment) Act-2007.

On dated 07.08.2018 at about 11:45am I, Sri Santanu Sinha, Station Manager Anara CCC Customer Care Centre, WBSEDCL along with,

Entered the premises of Mantu Bowri, S.O- Late Haku Bowri of Village- Anara, P.O- Anara (BO), P.S- Para, Dist-Purulia. and inspected his premises.

During inspection theft of Electricity was found, i.e. he/she was using Electricity dishonestly by direct hooking from LT line with using PVC wire arrangement and using one stand fan and one LED bulb.

Supply i.e. U/S 135 was detected.

From the above system he/she was using the following Electrical equipments i.e.

1. One Stand fan.
2. One LED Bulb.

Out of which we seized the following:

- 1> One Al hooking device
- 2> PVC cable (approx. 4m)

The seizure list are prepared at the site and the accused person refuse to signed in the seizer list .

The inspection team left the above premises at about 12.05pm on dated 07.08.2018. The accused person has committed an offence U/S-135(i)(a) of the Electricity (Amendment) Act-2007.

You are requested to take cognizance of the complaint and treat it as F.I.R and action may be taken as per Rule.
