During inspection theft of Electricity was found, i.e. he/she was using Electricity dishonestly by means of tampering from incoming of service cable at meter

Supply i.e. U/S 135 was detected.

From the above system he/she was using the following Electrical equipments i.e.

- 1) TV - 1 no. 3) Fan → 3 (ceiling fan) + 1 (table fan)
- 2) Tubelight - 1 no 4) Bulb - 9

Out of which we seized the following:

- 1) Single phase meter - 01 no. with tampering cable (Meter no - P1652686, HPL)
- 2) Main Switch (16A, 240V) with two pin plug

The seizure list are prepared at the site and the accused person refuse to signed in the seizer list.

The inspection team left the above premises at about 2:15 pm on dated 07.08.2018. The accused person has committed an offence U/S-135(i)(b) of the Electricity (Amendment) Act-2007.
