Entered the premises of Nisilk Bouri, S.O- Nonigopal Bouri of Village- Jorberia, P.O- Jorberia, P.S- Para, Dist-Purulia and inspected his premises.

During inspection theft of Electricity was found, i.e. he/she was using Electricity dishonestly by direct hooking from LT wire by PVC cable

Supply i.e. U/S 135 was detected.

From the above system he/she was using the following Electrical equipments i.e.

1. Bulb (100 watt) - 4 nos.
2. Fan (80 watt) - 4 nos.

Out of which we seized the following:

1. All hooking device
2. PVC cable - (120 feet approx)

The seizure list are prepared at the site and the accused person refuse to signed in the seizer list .

The inspection team left the above premises at about 7:10pm on dated 13.08.2018 .The accused person has committed an offence U/S-135(i)(a) of the Electricity (Amendment) Act-2007.
