Dear Sir,

I do hereby lodge a complaint being empowered by the Electricity Act. 2003 to the effect that *KAJI SALA MAHAMMAD*, S/O- LATE MAHASIN of VILL-HARIHARPUR, P.S. PARA, Dist-Purulia, the user of the electric has committed an offence of theft of electricity under section 135 (1) (b)of Electricity Act. 2003 read with amendment of Electricity Act. 2007.

On 24.08.2018 at about 11:08AM, I GOUTAM KUMAR MANDAL, SM of DUBRA PARA C.C.C, along with MR Avishek Das, SAE(E), Dubra Para CCC, MR Lakshman Mahato, SR LM, Mr. Manmatho Mahali, Sr.TSH, Dubra Para CCC, Mr Bhaktipada Mahato, TSH, Dubra Para CCC and MR Bilash Chandra Mahato HR GR-I TSH, Dubra Para CCC inspected the premises *KAJI SALA MAHAMMAD*, S/O- LATE MAHASIN of VILL-HARIHARPUR, P.S. PARA Dist Purulia. During inspection it was found that the said *KAJI SALA MAHAMMAD*, was enjoying electricity unauthorisedly by direct Tapping of service cable as hooking arrangement from WBSEDCL's nearest low tension over head line for running his 03 nos 75watt ceiling fan, 03 nos 9watt LED,01 no 65watt TV,01 no 160watts refrigerator approx load 0.477KW for domestic purpose, which is an offence u/s. 135 (1)(b)of Electricity Act. 2003 read with the amendment of Electricity Act. 2007.

As electricity theft was detected, his service line has been disconnected and seized as token and labeled by preparing Seizure list at site. Due to theft of electricity a loss of revenue was incurred to the WBSEDCL. The inspection team left the site at about 11:25AM.

As such *KAJI SALA MAHAMMAD*, S/O- LATE MAHASIN of VILL-HARIHARPUR, P.S.-PARA, Dist-Purulia has committed an offence of theft of electricity under section 135 (1)(b)of Electricity Act. 2003 read with amendment of Electricity Act. 2007. So, you are requested to take cognizance of this offence of theft of electricity treating this complaint as F.I.R.
