On dated 27/08/2018 at about 04:45pm, Sri Santanu Sinha, Station Manager Anara CCC Customer Care Centre, WBSEDCL along with,

Entered the premises of Subodh Bouri, S.O- Lt Jyoti Bouri of Village- Turradih, P.O- BHOWRIDIH, P.S- Para, Dist-Purulia and inspected his premises.

During inspection theft of Electricity was found, i.e. he/she was using Electricity dishonestly by direct hooking from LT wire by PVC Cable (Using 1/2 HP (0.37 kW) pump)

Supply i.e. U/S 135 was detected.

From the above system he/she was using the following Electrical equipments i.e.

- ① 1/2 HP Pump (Company - Mahendra) (0.37 kW)

Out of which we seized the following:

- ① 1/2 HP Pump (Company - Mahendra) (0.37 kW)
- ② PVC pipe ③ PVC cable (15m approx)
