Dear Sir,

I do hereby lodge a complaint being empowered by the Electricity Act. 2003 to the effect that **MD MAIMUR S/O- LATE MD SAFIA** of VILL-Astha para(Dubra), Dist-Purulia, the user of the electric has committed an offence of theft of electricity under section 135 (1) (b) of Electricity Act. 2003 read with amendment of Electricity Act. 2007.

On 28.08.2018 at about 2.15PM, I GOUTAM KUMAR MANDAL, SM of DUBRA PARA C.C.C, along with Mr. Avishek Das, SAE(E), Dubra Para CCC, Dubra Para CCC, Mr. Lakshman Mahato, Hg. Sr. LM, Dubra para CCC, Mr. Sanjoy Prasad, TSH, Dubra para CCC inspected the premises of **MD MAIMUR S/O- LATE MD SAFIA** of VILL-Astha para(Dubra) , P.S. Para, Dist-Purulia. During inspection it was found that the said **MD MAIMUR** was enjoying electricity unauthorizedly by direct tapping of service cable as hooking arrangement from WBSEDCL's nearest low tension over head line for running his 01 no ceiling fan, 01 no high speed stand fan, 04 nos LED, 01 no refrigerator of approx load 0.361KW for domestic purpose, which is an offence u/s. 135 (1)(b) of Electricity Act. 2003 read with the amendment of Electricity Act. 2007.

As electricity theft was detected, his service line has been disconnected and seized as token and labeled by preparing Seizure list at site. Due to theft of electricity a loss of revenue was incurred to the WBSEDCL. The inspection team left the site at about 2:35PM.

As such **MD MAIMUR S/O- LATE MD SAFIA** of VILL-Astha para(Dubra) ,P.S.-Para, Dist-Purulia, has committed an offence of theft of electricity under section 135 (1)(b) of Electricity Act. 2003 read with amendment of Electricity Act. 2007. So, you are requested to take cognizance of this offence of theft of electricity treating this complaint as F.I.R.
