I do hereby lodge a complaint empowered by enabling the Electricity act 2003 subsequently Electricity (Amendment) Act-2007 to the effect that Nepal Murmu S/O- Sanatan Murmu of Village- Sriramahuta, P.O- Pirscheli, P.S.- Punche, Dist - Purulia, has committed theft of Electricity U/S 135(1)(a) of the Electricity (Amendment) Act-2007.

On dated 09-08-18 at about 4.40 P.M, Sri Swarup Mandal, Station Manager, Manbazar Customer Care Centre, WBSEDCL along with,

entered the premises of Nepal Murmu, S/O- Sanatan Murmu of Village- Sriramahuta, P.O- \_\_\_\_\_, P.S.- Punche, Dist - Purulia and inspected his/her premises and found that he was using electricity unauthorisely by direct hooking from WBSEDCL LTDR System.

During inspection, theft of electricity was found, i.e., he/she was using electricity dishonestly U/S 135(1)(a) was detected. It was also found that he/she was using the following electrical equipments -
