I do hereby lodge a complaint empowered by enabling the Electricity act 2003 subsequently Electricity (Amendment) Act-2007 to the effect that Sri Rupchand Tudu S/O- Kalachand Tudu of Village- Sriramghatu, P.O- Pairachali, P.S.- Puncha, Dist - Purulia, has committed theft of Electricity U/S 135(1)(a) of the Electricity (Amendment) Act-2007.
