entered the premises of Sri Rupchand Tudu, S/O- Kalachand Tudu of Village- Sriramghutu, P.O- Pairachali, P.S.- Puncha, Dist - Purulia Purulia and inspected his/her premises and found that he was enjoying electricity unauthorisely by direct hooking from WBSEDCL's LT OH line

During inspection, theft of electricity was found, i.e., he/she was using electricity dishonestly U/S 135(1)(a) was detected. It was also found that he/she was using the following electrical equipments -
