Respected Sir,

I, the undersigned, have been running a "Marble and Tiles" Shop, named as "S.S.Marble" at Desh Bandhu Road, Purulia, and having a Go-down in the same name situated at Dulmi, Nadiha, within the jurisdiction of this P.S. to keep the stock. As a Care-taker and Custodian of the Go-down, Shankar Dutta, resident of Nadiha, near Shib Mandir was appointed as an employee from nearly last one year. But in the recent, last one month ago, after cross-checking of physical stock, it appeared that "Shankar Dutta" started stealing valuable items i.e. floor Tiles etc. and the value of stolen article is Rs.5,00,000/- (Rupees Five Lakhs) approximately. It is also learnt that - Shankar Dutta has sold out that stolen items to "Gopal Gupta", a Kabari-walls, (Scrap Dealer) of Amlapara, Purulia. Gopal Gupta once again sold out those stolen items to some other persons and one of them is * = "Badal Karmakar", a resident of Napit Para, Purulia. The stolen floor tiles may be recovered from him his custody.

You are requested to investigate and take needful legal action against those persons and recover my valuable stolen goods at your earliest.
