In producing herewith one arrested Accd. person namely Suren Chakraborty (42) S/O Lt Gopal Chakraborty of Vill.-Joytara P.S.- Pindrajora, Dist.- Bokaro A/P Baba Dhaba ,Chargail PS Purulia (M) Dist Purulia with seizure list and the following seized articles (1) 35(thirty five) sealed bottles of DIL SE 600 ml each (Country spirit) (2) 04(four) Empty bottles of DIL SE 600 ml each (3) 20 pecs empty plastic glass. 4) one polithin sheet, which is seized under proper seizure list.

I beg to submit a written complaint against the above noted arrested accused person to the effect that today on 07/08/18 in course of my mobile duty vide CC No 1554/18 and GD NO 323 dt 07/08/18 and when we reached at Chargali at 16.05hrs received a source information about selling of country spirit illegally at BABA DHABA shop ,conveyed the information to my O/C and as per direction myself along with my accompanied force held raid at BABA DHABA shop at 16.35hrs and found that, one person is selling country spirit and thee/four persons were drinking country spirit sitting on a pollithin sheet at BABA DHABA shop . Seen the police party they fled away and somehow we can able to apprehend the seller of country spirit. On being asked he disclosed his identity noted above. I asked him to produce valid paper for selling country spirit. But he failed to produce any valid papers/Licence in support of selling country spirit. He confessed his guily. Hence seized 1) 35(thirty five) sealed bottles of DIL SE 600 ml each (Country spirit) (2) 04(four) Empty bottles of DIL SE 600 ml each (3) 20 pecs empty plastic glass 4) one polithin sheet from the possession of said Suren chakraborty, one sealed bottle taken as sample duly labeled by me and arrested the accused person after observing all norms of arrest. Issued memo of arrest. Informed him and his relatives regarding the ground of arrest, seizure and arrest was done from 16.45hr to 18.35hrs

I ,then ,thoroughly and carefully enquired into the matter and from enquiry it reveals that the above noted Accd. person running the clandestine business of country spirit since long which comes under the purview of section 46(A)(C) of B.E.Act.

Under the fact and circumstanced I therefore pray a case U/S 46(A)(C) B.E.Act. may kindly be started against Accd. person namely Suren Chakraborty (42) S/O Lt Gopal Chakraborty of Vill.-Joytara P.S.- Pindrajora, Dist.- Bokaro A/P Baba Dhaba , Chargali PS Purulia (M) Dist Purulia
