I Sri Prashant Kishor, S/O - Kishori Prasad, A.E. & Station Manager of Telkalpara CCC of WBSSEDCL do hereby lodge my complaint empowered by the Electricity (Amendment) Act-2007 to the effect that Brihaspati Mahato S/O Lt Thakurdas Mahato of Vill - Mahara, PS-Purulia(M) has committed theft of electricity under section 135(1)(a) as detailed here under.

Today, i.e. on 10.08.2018 I, Prashant Kishor (AE&SM), along with Sri Debdas Bhattacharjee, Sr SAE(E), Akash Lal Sardar, Office Executive & Debdulal Banerjee, Sr.TSH of Telkalpara CCC, WBSSEDCL conducted a raid programme at village Mahara under Purulia(M) P.S. When our team at about 01.00 P.M. entered to the Domestic premises of Brihaspati Mahato, we found that he was enjoying electricity dishonestly by means of Direct Hooking from nearest LTOH Line and run Domestic appliances, thus WBSSEDCL losses revenue. As theft of electricity was detected in presence of the local witnesses, hooking wire dismantled and seized and seizure list prepared. The seized material labeled in presence of the local witnesses. The inspection team left the aforesaid location at about 01.15 P.M. after completion of inspection & necessary formalities.

Brihaspati Mahato S/O Lt Thakurdas Mahato of Vill - Mahara, PS-Purulia(M) has committed theft of electricity under section 135(1)(a) of the Electricity (Amendment) Act-2007.
