Respected Sir,

In producing herewith one arrested Accd. person namely Bibhuti Bouri (55) S/O Lt Aruni Bouri of Vill.-Gobardih Tola of Mamurjore, A/P Sarada Palley Tola of Mamurjore both are under P.S.- Puurulia(M), Dist.- Purulia with seizure list and the following seized articles (1) 40(forty) sealed bottles of DIL SE 600 ml each (Country spirit) (2) 10(ten) Empty bottles of DIL SE 600 ml each (3) 20 Pes empty plastic glass. 4) one poethin sheet which were seized under proper seizure list.

I beg to submit a written complaint against the above noted arrested accused person to the effect that today on 17/08/18 in course of my mobile duty vide CC No 1689/18 and GD NO 1044 dt 17/08/18 and when we reached at Gobardih at 18:30hrs received a source information about selling of country spirit illegally at Sarada Palley at his residence, conveyed the information to my O/C and as per direction myself along with my accompanied force held raid at the residence at 19.05 hrs and found that, one person is selling country spirit and three/four persons were drinking country spirit sitting on a poethin sheet on the courtyard of seller. Seen the police party they fled away and somehow we can able to apprehend the seller of country spirit. On being asked he disclosed his identity noted above. I asked him to produce valid paper for selling country spirit. But he failed to produce any valid papers/Licence in support of selling country spirit. He confessed his guilt. Hence seized (1) 40(forty) sealed bottles of DIL SE 600 ml each (Country spirit) (2) 10(ten) Empty bottles of DIL SE 600 ml each (3) 20 Pes empty plastic glass. 4) one poethin sheet which were seized under proper seizure list from the possession of said Bibhuti Bouri, one sealed bottle taken from Sl. No. 1 of the seizure list as sample duly labeled by me. Arrested the accused person namely Bibhuti Bouri after observing all norms of arrest. Issued memo of arrest. Informed him and his relatives regarding the ground of arrest. seizure and arrest was done in between 19:25 hrs. and 19: 55 hrs.

I, then, thoroughly and carefully enquired into the matter and from enquiry it reveals that the above noted Accd. person running the clandestine business of country spirit since long which comes under the purview of section 46(A)(c) of B.E.Act.

Under the fact and circumstance, I therefore pray a case U/S 46(A)(c) B.E.Act, may kindly be started against Accd. person namely Bibhuti Bouri (55) S/O Lt Aruni Bouri of Vill.-Gobardih Tola of Mamurjore, A/P Sarada Palley both are under P.S.- Puurulia(M), Dist.- Purulia Enclosures
