I do hereby lodge complaint empowered by enabling the electricity act.-2003 subsequently electricity (Amendment) act.- 2007 to the effect that Asis. Kr. Banerjee (present user) was enjoying electricity unauthorisedly i.e. by passing of energy meter by cutting of incoming service connection cable and due to this reason he - has committed theft of electricity U/s 135(b) of the electricity (Amendment) act.- 2007) on 03/08/18 at 5:05 PM.

Entered the premises of Asis. Kr. Banerjee (present user) Vill. Yarali Dhopa Lane, P.S. Purulia (T), Dist- Purulia, having Consumer No. 2A2A02720, Meter No. IPBB22412 and inspected his/her premises. During the inspection theft of electricity was detected i.e. by passing the energy meter i.e. U/S135(1)(b) was detected. The details of passing the arrangement was damage installation of the incoming wire and top 2 (two) piece of wire by which electricity directly flow to his house without energy registration in WBSEDCL energy meter.

From the above by-passing system he/she uses the following electrical equipments.

- 1) Electric A/c Machine - 01 no.
- 2) Freeze - 02 no.
- 3) Color TV - 02 no.
- 4) Water pump - 01 no.
- 5) Tube light - 04 nos.
- 6) Electric Fan - 04 nos.

Out of which I seized the following

- 1) Incoming tampering S/c cable along with Bypassing arrangement - 06 ft (approx).
- 2) ~~Sub~~ Sub with Holder - 01 no.

Seizure list was prepared at the site and accused person ~~refuse to sign~~/signed. The inspection team left the premises at 5:25 PM on 03/08/18. The accused person has committed an offence U/S135(1)(b) of the electricity act.-2003 subsequently electricity (Amendment) act.- 2007.
