Most respectfully begs to state:

1. That the land described in the schedule 1 and 2 of this petition are originally debotter property and belong to Shri Shri Lakhshmi Narayan Jiu and 1. Sailendranath Sarkar, 2. Mukunda Murari Sarkar, 3. Sachinandan Sarkar, 4. Subhash Chandra Sarkar and 5. Nanda Kisorsh Sarkar and others are the shebait in respect of the schedule properties and possession of the deity was finally framed and published in R.S.R.O.R., which emanates from debattar case no. 14/ 68 of 2008.
2. That the father of the petitioner, namely Subhash Sarkar, after the death of original shebait namely Sailendranath Sarkar and others is now functioning as shebait and at present as he is old and suffering from various old age ailments the present petitioner is looking after the seba-puja of the deity.

3. That in an around October 2017 it has come to the notice of the petitioner and his family members that accused no.1 is transferring the property to various persons and on search in the office of D.S.R. and A.D.S.R., Purulia it could be learnt that the accused no.1 quite illegally transferred the property Schedule 1 and 2 property respectively in favour of accused no.2 and 3 by two deed of sale bearing no. 2604 for the year 2017 and 2606 for the year 2017 respectively of the office of the A.D.S.R., Purulia.
4. That on scrutiny of the two deeds it transpires that the accused no.4 was the deed writer while accused no. 5 and 6 was the identifier and the witness of the deeds. It also appears from the deed that there are exchange of money between the alleged vendor and purchaser and the sale price was abnormally low than the market price.
5. That on further scrutiny of the deeds that the accused no.1 has claimed that Sailendranath Sarkar, son of late Sashibhusan Sarkar had transferred the scheduled 1 and 2 properties to the accused no.1 by a deed of sale bearing no. 2594 of D.S.R. Purulia on 15.04.1989.
6. That your petitioner had again searched for the deed from the office of D.S.R. Purulia and in order to avoid confusion also obtained certified copy of deed no. 2594 for the year 1989 from the office of the A.D.S.R. (Joint) Purulia
7. That on the scrutiny of the certified copy of the deed from the office of the D.S.R, Purulia, it reveals the same was executed by one Durlav Sao and Krishnakishor Sao, sons of Nilmoni Sao, of village -Thakurshima, P.S.- Arsha, in favour of Jotylal Mahato (witness No. 4), son of Late Asari Mahato, of Village- Ulugoria . P.S.- Arsha and the property covered under the deed was

- of Mouza- Thakurshima, P.S.- Arsha, Dist.- Purulia, and accordingly does not tally with the present schedule 1 and 2 properties.
8. That on perusal of the certified copy of the deed issued from the office of A.D.S.R. Purulia it reveals that one Gadadhar Mahato, son of Late Golok Mahato of Village- Rangamati , P.S.-Arsa had transferred some property situated at Mouza-Torang , P.S.- Arsha in favour of Adalat Mahato, Son of Bahadur Mahato of Village- Khayertar , P.S.- Joypur, Dist.-Purulia.
 9. That the predecessor in interest of the present petitioner of the property were/are the owners of the property which could be detected in simple inspection and the possession of the family of the petitioner is well known in the locality. The witness No. 2 and 3 are the co-sharers of the petitioner.
 10. That the accused no.1 with the full knowledge that he is not the real owner of the schedule property nor had he obtained the property from the rightful owner, by deliberate suppression and /or giving false declaration of the existence of the some imaginary deed/ deeds had manufactured the deeds and committed the offence cheating, forgery for the purpose of cheating and attempted to use forged document as genuine.
 11. That the accused no 2 & 3 with full knowledge that the accused no.1 has no right to transfer the schedule land (1 and 2) by hatching up the conspiracy and helped the accused no.1 to manufacture such forged document and payment of the less consideration money than the market value indicate their ulterior motive.
 12. That the rest of the accused persons also aided and abetted accused no. 1 to 3 to manufacture such type of forged documents at the office of ADSR, Purulia and hence within the jurisdiction of Purulia (Town), P.S.

13. That the petitioner went to Purulia (Town) P.S. but the police refused to take any action. The matter was again reported to S.P, Purulia on 30.1.2018, but till date no action is taken.
14. That this case requires through police probe including examination of witnesses who are residents of different places, seizure of documents, etc.

It is, therefore, prayed that your Honour may graciously be pleased to direct the police of Purulia (Town) P.S to treat this petition as a F. I. R. and to cause investigation in respect of the alleged incident.
