I left PS to verify the input vide Purulia (T) PS GDE No 515 dated 09.08.18. After reaching the spot, it could be observed that, above persons were preparing to start the rally with huge amount of Lathi, flag with big Lathi etc in their hands. Myself with accompanying officers & force asked them not to conduct their rally and the "Jail Bhoro" / Law Violation programme for maintenance of Law & Order situation at Purulia town, but they did not listen to my words and started their procession by showing those Lathi etc. I informed the fact to my superiors. I also communicated with the office of the DM, Purulia for deputing an Executive Magistrate. With my accompanying officers & force tried to resist them for conducting such unlawful procession. But, they became violent and over powering us they continued their unlawful rally. Finding no other way we declared the mob as unlawful assembly and directed them to disperse. But the mob became furious and overpowering us they conducted the rally. At about 15:05 hrs, when they reached near the DM office main gate of Purulia, the police party of Purulia district tried to stop them by placing

Due to their assault, (1) SI Debasis Bandopadhyay, O/C Purulia(M) PS, (2) SI Sekhar Mitra, O/C Kenda PS, (3) JC/981, Manoranjan Das of Assault Group, Purulia (4) CVF Sanjoy Dutta of Purulia (T) PS and other police personnel received serious bleeding injuries on head and persons and were shifted to Purulia Sadar Hospital for treatment. They also damaged many Govt Guard rails. Finding no other alternative, I prayed to Sri Sourav Chatterjee, WBCS (Exe), DM DC, Purulia and on duty Magistrate to give order for mild Lathi charge to disperse the mob. Availing the order, we started to disperse the mob by mild Lathi charge and apprehend above 04 offenders when others fled away. I seized some Lathi, Lathi with flags, pieces of stone, Govt. Guard Rails etc from PO and also from possession of those arrested persons in separate seizure lists with all formalities.
