To The Officer in charge Raghunathpur P.S. Dist. Purulia

Sir,

In producing herewith one truck bearing No. WB 37C/1235 loaded with stolen coal approx 15 (Fifteen) Tons with proper seizure list. Fact of the case in brief is that on 01.08.18 myself along with C/06 Debdas Mukherjee, C/732 Gopal Ch. Das and C/844 Tufan Swadagar were on Naka Checking on Raghunathpur – Barakar road and received a source information that the above noted vehicle is coming loaded with coal from Neturia side towards Raghunathpur. After receiving this information, I informed the matter to O/C Raghunathpur PS and as per direction of O/C Raghunathpur we had been to Raghunathpur – Barakar road near Haridih bridge and placed Naka Checking with a view to intercept the said vehicle. At 13:25 hrs we found that one truck is coming from Neturia side. Seeing police party the driver of the said truck attempt to flee away with the truck but on being chased the driver stopped the truck on road and fled away beside the road. I searched the truck and found that about 15 (Fifteen) Tons coal loaded in this truck and the key of the truck has been left away in the truck by the driver. We searched the surrounding area to find out the driver but failed to trace out him. No public witness was available there. It is reasonable to believe that driver and owner of the said truck collected the said coal either theft or by any illegally means and transporting to run a clandestine business for wrongful gains and to run this business. Accordingly, I seized the said truck loaded with approx 15 (Fifteen) Tons coal under proper seizure list.

I therefore pray that kindly lodge an FIR against the driver and owner of the truck bearing No WB 37C/1235 as per law and arrange its investigation.
