Sub: Prayer for lodging FIR.

Sir,

With due respect I ASI Joydip Singha of Raghunathpur PS beg to state that I have been detailed for L/O duty along with force vide CC No 664/18, GDE No 1261 dtd 27.08.18 at about 09:05 hrs at Mangalda - Moutorh GP Office in c/w First meeting with the Elected member of Mangalda - Moutorh Gram Panchayet for formation of Pradhan and Upa - Pradhan of the said Gram Panchayet. I reached there at about 09:35 hrs.

During formation of Pradhan and Upa Pradhan of Mangalda - Moutorh Gram Panchayet at the office building of above noted Gram Panchayet at about 12:45 hrs. a huge number of BJP supporters under the leadership of (1) Goutam Mishra S/o Lt. Dhananjoy Mishra of Vill.- Dumurkola, PS - Raghunathpur, Dist- Purulia, (2) Khudiram Mandi S/o Chhotolal Mandi of Vill.- Pratappur, PS - Raghunathpur, Dist- Purulia, (3) Shyamapada Karmakar S/o Khudiram Karmakar of Vill.- Charanbandh, PS - Raghunathpur, Dist.- Purulia, (4) Tapas Bauri S/o Bilash Bauri of Vill.- Bagmantri, PS - Raghunathpur, Dist.- Purulia, (5) Rajen Bauri S/o Mohan Bauri of Vill.- Moutorh, Satana, PS - Raghunathpur, Dist.- Purulia and (6) Mitan Bauri S/o Mihir Bauri of Vill.- Moutorh, Majkulia, PS - Raghunathpur, Dist.- Purulia forcefully entered into the Gram Panchayet premises with deadly weapons. I requested them to live the Gram Panchayet premises to far 200 meters as SDO, Raghunathpur passed an order on 26.08.18 in c/w Misc. Case No 183/18 dt 26.08.18 U/S 144 (2) Cr. P.C. which was enforced from 27.08.18 at 09:00 AM to completion of the board formation but the unruly BJP supporters did not pay heed my words. I also try to turn it over the BJP supporters from Gram Panchayet Premises with the help of my forces. But at that time the unruly BJP supporters throw stone, peace of bricks etc. towards ourselves. As a result I along with force received grievous injury by throwing stone and peace of bricks and the unruly BJP supporters also obstruct us to perform our Govt. duty and they also set fire upon the Govt. file, papers. As a result the Govt. file and papers fully burnt and they also damaged the other valuable articles of Mangalda - Moutorh Gram Panchayet Office.

Finding no other option I have requested O/C Raghunathpur PS to send more force at about 14:05 hrs. Thereafter O/C Raghunathpur PS send the forces under the charge of officer namely ASI Sujoy Kr Pati and officer at Mangalda - Moutorh Gram Panchayet. Seeing the strength of force, the unruly mob also throw stone of bricks upon the officers and force and as a result ASI Sujoy Kr Pati received grievous injury on his person by stone thereafter we manage to turn it over the unruly BJP supporters from the Gram Panchayet premises.

I have seized 04 pieces of broken bricks, 05 pieces of Stone and burnt article as sample those which were thrown and burnt by the unruly BJP supporters. At that time we managed to apprehend the above noted persons. I arrested the accused persons namely (1) Goutam Mishra S/o Lt. Dhananjoy Mishra of Vill.- Dumurkola, PS - Raghunathpur, Dist- Purulia, (2) Khudiram Mandi S/o Chhotolal Mandi of Vill.- Pratappur, PS - Raghunathpur, Dist- Purulia, (3)

Shyamapada Karmakar S/o Khudiram Karmakar of Vill.- Charanbandh, PS - Raghunathpur, Dist.- Purulia, (4) Tapas Bauri S/o Bilash Bauri of Vill.- Bagmanmi, PS - Raghunathpur, Dist.- Purulia, (5) Rajen Bauri S/o Mohan Bauri of Vill.- Moutorh, Satana, PS - Raghunathpur, Dist.- Purulia and (6) Mitan Bauri S/o Mihir Bauri of Vill.- Moutorh, Majkulia, PS - Raghunathpur, Dist.- Purulia.

Therefore I pray before you that I pray for starting an FIR against (1) Goutam Mishra S/o Lt. Dhananjoy Mishra of Vill.- Dumurkola, PS - Raghunathpur, Dist.- Purulia, (2) Khudiram Mandi S/o Chhotolal Mandi of Vill.- Pratappur, PS - Raghunathpur, Dist.- Purulia, (3) Shyamapada Karmakar S/o Khudiram Karmakar of Vill.- Charanbandh, PS - Raghunathpur, Dist.- Purulia, (4) Tapas Bauri S/o Bilash Bauri of Vill.- Bagmanmi, PS - Raghunathpur, Dist.- Purulia, (5) Rajen Bauri S/o Mohan Bauri of Vill.- Moutorh, Satana, PS - Raghunathpur, Dist.- Purulia and (6) Mitan Bauri S/o Mihir Bauri of Vill.- Moutorh, Majkulia, PS - Raghunathpur, Dist.- Purulia and unknown others under proper section of law.
