Sub:- Written complaint against (1) Saheb Bauri, resident of word No. 12, Nanduara (2) Akash Bauri, resident of Word No. 12, Nanduara (3) Kamal Bauri, resident of Word No. 12, Nanduara and other unknown persons.

Sir/Madam,

This is to draw your kind attention to the fact that I, Moloy sarkel S/O. Lt. Praphulla Sarkel, permanent resident of Kulti Thana More, P.O. & P.S.– Kulti, Dist.– Bardwan, a secretary of Raghunathpur Kisholoy Society, Joychandi Hill Resort. I am also one of the partner and running the said resort under lease from the Govt. of West Bengal.

That since long i.e from the inception of this resort above referred persons of the locality started to disturb towards the formation of the Joychandi Hill Resort which is well known to all the well wishes of the society at large and the administrative authority concerned. The persons who are creating nuisance regarding the matter are very much funny, odd and trifling that due to this governmental upliftment the local people are not getting the opportunity to use the nature for their natural calls like lavatory, bath in the tanks, cattle bath etc. issues which is very much painful approach towards the nature and environment also unhygienic in the locality too.

You must be aware that the entire project has been established and being extended and modified by the Govt. of West Bengal under the supervision of concerned authorities and it should not be hampered by the boisterous associates under the leadership of the persons mentioned in the subject stated here before. Day by day they are creating all sorts of illegal act/acts, activity/activities by damaging and breaking govt. Premises thereon within the premises and outside the premises.

Kindly note that today from the morning at about 11:00 a.m. onwards a huge number of unknown persons assembled with life taking weapons and attack under the leadership of the above referred persons namely (1) Saheb Bauri, (2) Akash Bauri (3) Kamal Bauri and others entered into the premises and damaged, ransacked the valuable articles like costly beds, mattresses, pillows, LED T.V., refrigerator, plants of the garden etc. forcibly at their own whims under their muscle power.

When I raised objection they used filthy languages and threatened me in such a fashion as if they are the boss of the locality. As such I got both physically and mentally hurt and really frightened as above named persons are ready to kill me at any time and uttered by saying no one can save my life. Even administrations too in their hands and under their clutch.

Under the above facts and circumstances I find no other alternative secondary juncture but to agitate the matter before you for taking appropriate action immediately after proper investigation to that effect otherwise I shall suffer irreparable loss, injury and life. Hope you will do the needful as expeditiously as possible from your end in order to avoid future complications also for the ends of justice.
