Re: This is in continuation to our FIR Memo vice No. RT/PB/2IR/W/2 dated 09.08.2015 on  
the matter mentioned above under the subject.

In this context, I beg to inform you that on the 11th instant day, 08.08.2018, the Senior Officers of DVC, RTPS were assaulted by the disgruntled persons. The complaint in writing filed by them are reproduced herein below:

Transcript of Smt D. Deb, DCE(C) dated 08.08.2018:

Yesterday, during the agitation by some villagers, the undersigned was trying to enter into the Panchayat premises by walking, less 20 m away from the Main Gate, a group of people threatened with dire consequences. Suddenly, some people led by the gheraoed me and threatened physically assaulted the undersigned.

  - Shri Basanti Bauri, S/o Late Bhagabati Bauri, Vill- Naragachha.

5. Shri Banshi Beuri, S/o Late Brijajitari Beuri, Vill- Nainguda. The undersigned while tended for safety, those villagers chased him and kicked him and attempted to murder. After this incidence the undersigned became very much scared. This is the first time the undersigned has been physically assaulted during his tenure at KIPDS for more than 30 years. The CCTV installed at the main gate has captured the entire incident."

Complaint of Sri Sandip Baruwa  
With due respect I want to state the details of the incident that took place with me, Sandip Baruwa, A/C(M), Emp. id. 594527 on 07.08.2018. While I reached near the Main Gate of Shri Gurudwara, Akal Takht Sahib, Gurdaspur on my way to join shift A (Morning) duty at 07:00 AM I saw a huge gathering of the Sikhs on the road to Akal Takht Sahib. They told me to go back to Akal Takht Sahib. I turned back and stood at a safe distance from them. Suddenly, 10-15 people came forward and started hitting me twice and used abusive language while I was trying to informing FIR against them.

As per my knowledge, Name of two persons among them are Shri Subhamoy Sarkar & Mr. Chittaranjan Ray.
