Sub: Request for Registration of First Information Report(FIR).

Sir,

This is in continuation to our FIR Memo vide No. RT/PL/FIR/872 dated 09.08.2018 on the matter mentioned above under the subject.

In this context I beg to inform you that on the ill fated day, 08.08.2018, the Senior Officers of DVC, RTPS were assaulted by the disgruntled persons. The complaint in writing given by them are reproduced herein below:

Complaint of Shri D. Deb, DCEIC dated 08.08.2018:

"Yesterday, during the agitation by some villagers, the undersigned was trying to enter into the Plant premises by walking. Just 20 m away from the Main Gate, a group of people gathered and threatened with dire consequences. Suddenly, some people led by the following villagers physically assaulted the undersigned:

1. Shri S. Bhomey Sarkar alias Bappa Sarkar, S/o Shri Suresh Sarkar, Vill-Naragoria
2. Shri Amit Chakraborty, S/o Shri Krishnappa Chakraborty, Vill- Naragoria
3. Shri Tannoy Kundhakar, S/o Late Ananda Kundhakar, Vill- Naragoria
4. Shri Jayanta Mallik, S/o Shri Kalipada Mallik, Vill-Poora.
5. Shri Banshi Bauri, S/o Late Bhajhari Bauri, Vill- Naragoria.

The undersigned while rushing for safety, those villagers chased him and kicked him and attempted to murder. After this incidence the undersigned became very much scared. This is the first time the undersigned has been physically assaulted during his tenure at RTPS in more than 04 years. The CCTV installed at the main gate has captured the entire incident."

Complaint of Shri Sandip Burnwal, AEM dated 08.08.2018:

"With due respect I want to state the details of the incident that took place with me, Sandip Burnwal, AEM, Emp. Id. 594527 on 07.08.2018. While I reached near the Main Gate Complex on my way to join shift (Morning) duty at 07:05 AM I saw a huge gathering at the gate. They told me to go back knowing which I turned back and stood at a safe distance from the gathering besides the road to attend a car. Suddenly, 10-15 people came forward threatening me. One of the also hit me twice and used abusive language while I was trying to start my bike. After starting my bike I got away from there. This is for your kind information and lodging FIR against them.

As per my knowledge, Name of two persons among them are: Shri Subhoday Sarkar, S/o Anil Chakraborty."
