



I do hereby lodge suomoto complaint against 1. Manas Mukherjee s/o Lt. Fonibhusan Mukherjee of village Namo Kotaldih, 2. Arjan Goswami of Narmokutaldih, 3. Tarun Mondal s/o Magaram Mondal of Ramchandrapur, 4. Arup Acharyee s/o Sibapada Acharyee of Ramchandrapur, 5. Sujit Chatterjee s/o Lt. Naren Chatterjee of Ramchandrapur, 6. Molay Acharyee s/o Unknown of Ramchandrapur, 7. Subir Chatterjee s/o Lt. Ram Chatterjee of Ramchandrapur, 8. Keshab Roy s/o Jamini Roy of Namo Kotaldih, 9. Santunu Nandi s/o Lt. Shastri Pada Dhibar S/O- Unknown of Muradi all of PS-Santuri, Dist-Purulia and approx 300 others supporters of BJP to the effect that today (27.08.18) from 12:00 hrs and onwards was fixed for Election of Pradhan and Upa-Pradhan of Muradi GP. The following staffs of Santuri BDO Office and Muradi GP were deputed for Election duty, Shri Rajesh Kumar; Joint BDO of Santuri Block was the observer, Abdul Al Masud, FEO of Santuri Block; was the presiding officer, Litan Mallick; Panchayat Clerk was the assistant, Uttam Mondal, Gram Panchayet Sahayak resolution writer and Subhas Bouri was the Group-D staff of Muradi GP. I like to mention here that as per order of SDO Raghunathpur prohibition or restriction on assembly of five or more persons within 200 meters from Muradi GP office premises was remain enforce from 09:00hrs of 27.08.18 (This refers to Misc Case No. 183/18 Dtd. 25.07.18 U/S-144 (2) Cr.P.C) and in this regard printing was done for general awareness. As per schedule, I along with officers (SI Anjan Kr. Biswas, ASI Krishna Pada Gorain, ASI Narayan Mukherjee, ASI (ABI) Buddhadeb Karmakar, ASI (ABI) Binoy Kisku) and force (Vide Special CC No. 45/18, 46/18, 47/18 & 48/18) have taken up our duty in proper uniform at about 09:00 hrs for the Pradhan and Upa-Pradhan election of Muradi GP. All the above noted staffs of BDO office & Muradi GP office and 10 winning candidates of Muradi GP entered in the GP office in due time and election process closed at about 13:30 hrs. Completing the election process, all the election related staffs left the GP office. Then, all the winning candidates of BJP left the GP office's premises showing their grievances as they have been defeated in Pradhan and Upa-Pradhan election. After that all of a sudden, all the above noted accused persons came to Muradi GP office violating the order of SDO Raghunathpur being armed with deadly weapons forming unlawful assembly and started pelting stones, bricks. The mob GHERADED us and started to assault through lathi, stick with a view to kill us. We tried our level best to manage the situation. We request them for several times for not violent but they didn't pay any heed. In the mean time, the mob became more furious and damaged motor cycles. They also damaged the Govt. property of Muradi GP office's. I tried to disperse the said unlawful assembly through negotiation and persuasion to pacify the situation and to control the mob. But, again they did not pay any heed to my request and command. I loudly commanded the said unlawful assembly with the help of loud speaker to disperse. But all goes wrong and the mob became more furious being excited & instigated by the above noted accused persons. Finding no alternative way, in order to prevent further mischief and to save the life of Police personnel; CVs, I command to fire Tear Gas shells to disperse the assembly with no injury and accordingly my accompany force fired 03 numbers 1S Shells Soft Nose (Cartridge No. 39, 50 & 14) & One Stun Shell HDPE (Cartridge No. 61) and one Stun Grenade (Lot No. 51). After the firing of Tear Gas shells the mob seriously and violently attacked us with deadly weapons and pelting stones heavily. As a result I and SI Anjan Kr. Biswas, ASI Krishna Pada Gorain, ASI Narayan Mukherjee, JC/748 Somendu Lohar, JC-752 Ujjwal Satpati, C/o Sujoy Bhandary of Muradi GP received serious injury over our persons. At this point of time we all to gather chase the mob by raising our lathi at about 15:15 hrs and the mob showed some inclination to retreat and some of them failed down on the rocky surface and suffered some minor injury. Accordingly, I stop chasing. After waiting few minutes, we left the spot and arranged our medical treatment at Santuri PHC in which ASI Narayan Mukherjee was sent to Raghunathpur Super Specialty Hospital with serious head injury and admitted there in a critical stage. All the above noted accused and others being forming and unlawful assembly damaged and caused mischief the Govt. property of GP office and assaulted us with a view to kill us and committed offence U/S-147/148/149/353/332/333/307/427 IPC & 9 MPO Act & 3 PDPP Act.

Hence, on return back to PS, I am initiating Santuri PS case No. 45/18 Dtd. 27.08.18 U/S-147/148/149/353/332/333/307/427 IPC & 9 MPO Act & 3 PDPP Act against all of them as noted above suomoto and directed SI Mahadeb Rana to investigate the case.
