Sub-FIR against illegal sand extraction at Deuli mouza under P.S.Santuri.

This is to inform you that during my inspection to Deuli Sand Ghat under Santuri PS today on 16/08/2018 at 09.30 am, it is found that some unknown persons are using two Boats with Pump for mining of sand in the said Ghat closely adjacent to Paschim Bardhaman side at Damodar River.

As per existing guidelines of the Government, no machinery shall be allowed for sand mining in the river. Moreover the period from 01/07/2018 to 30/09/2018 is a prohibited period for sand mining in the river.

Apart from that in a meeting dt. 05/06/2018 in the chamber of SDL&LRO Raghunathpur with auction holders of sand mining under Santuri PS a resolution was taken that no Boat and Pump with any machineries will be allowed for extraction of sand in the river Damodar under PS Santuri.

You are therefore requested to take a stern action against the alleged illegal persons who involved in extraction of sand by Boats at Deuli Mouza under Santuri PS who is liable to be prosecuted under rule 33 of WBMM Rules 2002 read with Sec.21(1) of Mines & Minerals (Regulation & Development) Act 1957. Sec.50(1) of WBMM Concession rules 2016.
