has committed theft of electricity T.S. 133 of The Electricity (Amendment) Act, 2007.

and inspected the premises. During inspection theft of electricity was detected i.e. he
was using electricity dishonestly by drawing illegal hooking from the nearest L.T.O.H. line of
W.B.S.E.D.C.L. (T.S. 133 (1)) was detected.

From the above arrangement he/she was using the following electrical equipments

- 1) Bulbs = 2 no. w. 2 nos = 30w
- 2) Fan = 2 no. w. 2 nos = 240w
- 3) CFL = 4 nos (15w) = 4 x 15 = 60w
