In producing herewith the arrested accused persons namely (1) Aurabindo Karmakar (50 Yrs.) S/O Lt. Banku Bihari Karmakar of Nandura PS- Raghunathpur Dist- Purulia, (2) Md. Nadeem Uddin (19 Yrs) S/O Syed Munna of Lower Beniasole, PS- Adra, Dist- Purulia, (3) Shankar Rakshit (49) S/O Lt. Haradhan Rakshit of Raghunathpur ward No.-1, P.S- Raghunathpur, Dist- Purulia, 4) Shyamapada Roy (40) S/O Lt. Satya Prasad Roy of vil- Kotaldi, P.O- Murardi, PS- Santuri, Dist- Purulia 5) Tapan Majhi (50) S/O Narugopal Majhi of Nandura, PS- Raghunathpur Dist-Purulia, (6) Shubnath Karmakar (24) S/O Lt. Magaram Karmakar of Nandura, PS- Raghunathpur, Dist- Purulia (7) Bubun Dey (38) S/O Amit Singhania(24) S/O Sanjay Kumar Singhania of Sikrapur, Raghunathpur, PS-Raghunathpur, Dist- Purulia, (9) Jhulan Mishra (24) S/O Lt. Shanli Gopal Chowdhury of Nandura, PS- Raghunathpur Dist- Purulia before your honour's court along with the following seized articles. 1) Board money amounting to RS- 2,20,009/- (Two Lakhs twenty eight thousand and nine rupees), (2) 104 nos. of playing cards , (3) 02 nos. of 'SATRANJI' (01 red floral design and 01 brown floral design) and (4) 04 new sets of playing cards as per seizure list.

I beg to report that on 03.09.18 at 20.25 hrs. O/C Adra PS received a secret information that one gambling with huge amount was going on in a room of 1st floor of New Punjab Bar which is owned by one Bittu Singh S/O Gurucharan Singh of Lower Beniasole, Adra PS- Adra Dist- Purulia, near Joychandi Pahar Railway Station, Adra under Adra PS. The matter was diarised vide Adra PS G.D.E No- 118 Dtd- 03.09.18. Accordingly, as per order of O/C Adra PS I. S.I Supratik Mondal along with (1) SI Bibekananda Ganguly (2) C/1434 Jagannath Mondal (3) C/ 201 Rabindra Nath Nag (3) JC/411 Pinku Saha (5) JC/572 Ajay Giri (6) JC/185 Prasenjit Shit (7) RJC/1459 Sk. Ilahiul (8) JC/510 Nitesh Shaw (9) RJC/1538 Biresh Malati and (10) JC/491 Pranab Kumar Dey left for New Punjab Bar near Joychandi Pahar Railway Station, Adra under Adra PS to work out the information. At about 20.55 hrs. we reached near the bar and very slowly and cautiously approached towards the said room situated at the 1st floor of the bar where the gambling was reportedly going on. Within a few moment it was clear that the persons present there were continuing gaming with playing cards in exchange of money causing wrongful loss to one and wrongful gain to another. After that I asked my associate staffs to cordon the place and within a moment the place was cordoned by Police party. After that we asked their identity and the persons disclosed their name and address as noted above. It was found that a huge amount of currency note of different denominations were kept on gaming board (01 red floral design and 01 brown floral design 'SATRANJI placed on the floor) and playing card were also found. On demand the persons clearly confessed that all of them were gambling with playing cards in exchange of cash for wrongful loss to one and wrongful gain to another. We searched for the public witnesses but none was available. After that in presence of persons noted above the Board money amounting to RS- 2,28,009/- (Two Lakhs twenty eight thousand and nine rupees) of different denominations as noted in the seizure list, 104 nos of playing cards , 02 nos. of 'SATRANJI' (01 red floral design and 01 brown floral design) and 04 new sets of playing cards were seized from the gaming board.

As such for committing offence punishable U/S 3 & 4 of W.B.C & P.C Act all the above noted 10 (Ten) persons were arrested, issuing arrest memo after complying all directions and guidelines regarding arrest.


From the statement of accused persons it was clear that the gaming was going on under guidance and full of knowledge of the owner of the said bar namely Bittu Singh S/O Gurbachan Singh of Lower Beniasole, Adra PS- Adra Dist- Purulia.

Therefore I pray before you that one specific case may kindly be started under proper sections of law against the above noted 11 (eleven) accused persons and arrange for its investigation.
