During inspection theft of electricity was found, i.e. he/she was using Electricity dishonestly by means of direct hooking from near by LT 0.1 Line of WBSEDCI by Single Core PVC wire and hooking device, though there are no existing connection in the name of accused person bearing Con Id No-200231676 and Meter serial no - 11912179.

Supply i.e. U/S 135 was detected.

From the above system he/she was using the following Electrical equipments i.e.

(i) Three - 6x 100w x 6x 200w, (ii) Fan - 6x 80w, (iii) 11V LED - 1x 12w.

(iv) Water Pump - 1x 370w x 370w [Total load - 1610w]

Out of which we seized the following

(i) Three Core PVC wire connected with hooking device 2.2 m approx

The seizure list are prepared at the site and the accused person refuse to signed in the seizer list.

The inspection team left the above premises at about 7:40 p.m. on dated 07-09-2018. The

accused person has committed an offence U/S-135(i) (A.) of the Electricity (Amendment) Act-2007.
