In proceeding herewith we arrested accused person namely Rabi Bouri (30 years) S/o L. Gopal Bouri @ Jatra of near Choto Hospital, Adra, PS-Atra, Dist- Purulia and seized articles 1. One black color luggage bag with Logo "M'steraya Best Quality Bag" length - 71 cm, width - 32 cm and height- 36cm, 2. Cannabis (Ganja) 25.8 kg. Marked as Exhibit "A", 3. 100 gm Cannabis (Ganja) in a brown envelope, Marked as Exhibit "A-2", 4. 100 gm Cannabis (Ganja) in a brown envelope, Marked as Exhibit "A-3", 5. One old Bi-Cycle (Brand- KW Model No- 800), 6. weighing instruments along with 5 kg. 1 kg. 500 g. 200g. 100g weight, 7. S. Kosalik Burpex, O/C Adr. Police Station de macy logga, a so and I complain stage, our arrest of accused person namely Rabi Bouri (30 years) S/o 14. Gopal Bouri @ Jatra of near Choto Hospital, Adra, PS Atra, Dist- Purulia to the effect that on 16.09.18 at 15.55 hrs. I get inform about the above named accused person was coming from Raghunathpur side to Adra riding on a bi-cycle through Adra Raghunathpur Road with some contraband articles in bag at the back side carrier of the bi-cycle. The information was duly entered in PS CD Book vide Adra PS G.I.P. No- 542 Dt- 16.09.18.

Accordingly myself along with SI Suparnik Mandal, ASI 569 Parimal Tewary, Const Chittaranjan, Ct- 25 Tapar Das Bouri, Jef- 25 w. Jh Govt. vehicle bearing No- WB58U08905 at 15.55 hrs vice Adra PS I.C. No-2622 dated 16.09.18 and Adra PS G.D.E. No-543 dated 16.09.18 to work out the information vide Adra PS G.D.E. No- 542 D.d- 16.09.18.

At 16. 5 hrs. we arrived near Bhunki Kali Mandir on Adra Raghunathpur Road and started waiting for the said person standing at the eastern side of the said Mandir. At 16.25 hrs. we noticed that one person was coming from Raghunathpur side riding on a bi-cycle with a big luggage bag at the back side carrier of the bi-cycle. We gave signal to stop the cycle but the rider willfully ignored the signal and tried to flee away along with his bi-cycle. He, however, we managed to dozen him after a small chase. Being asked he disclosed his identity as Rabi Bouri (30 years) S/o LL Gopal Bouri @ Jatra of near Choto Hospital, Adra, PS-Atra, Dist- Purulia. On physical examination it is found that there is one big size luggage bag at the back side carrier of the bi-cycle. From the odor of its contained of the bag it appears to be cannabis.

Informed the development to S. Suparnik Kr. PatPak, duty officer of Adra PS and directed him to send e-mail to the SDIO, Regional P.z.c to do the Executive Magistrate to be present at P.O. during the search and also to send e-mail to Ct. KasLpur requesting him to be present during the search. Accordingly I detained the person and bi-cycle with bag and started waiting for the arrival of Executive Magistrate and Ct. KasLpur. By this time two persons namely 1) Ranjan Lewis S/o Francis Lewis of Palashkola, PS- Adra, Dist- Purulia Ct. Pt. suran Chatterjee S/O Digbijoy Chatterjee at near Post Office, Adra, PS-Atra, Dist- Purulia were passing by there. I approached them and informed the matter to them and requested them to be present there as witness during search. I then asked Palashkola Chatterjee S/O Digbijoy Chatterjee of near Post Office, Adra, PS-Adra, Dist- Purulia in writing whether he has any weighing machine or balance. He has whether he is ready to weigh the Cannabis (Ganja). He replied in writing and brought the weighing instruments from his home at 17.30 hrs.

At 17.55 hrs. Shri Partha Chakraborty, WBCS (Exe), DM & DC, Raghunathpur (Deputed by SDIO, Raghunathpur) as Executive Magistrate and Shri Rajat Kanti Paul, Ct. KasLpur arrived at the P.O. i.e. near Bhunki Kali Mandir on Raghunathpur Adra Road. Then I asked the detained person to wait to search ourselves. Accordingly he searched all persons persons thoroughly but found nothing objectionable. He disclosed this in writing.

After that we asked him that we would search him and his bag. I asked him in written whether he wanted the search to be conducted in presence of Executive Magistrate and Gazetted officer. He replied affirmatively I informed the matter to the Executive Magistrate & CI Kashipur.

Then I started searching the person and his bag. During search I found that the bag which was at the back side carrier of the bi-cycle was packed with Cannabis (Ganja).

Then Kalimdar Chatterjee S.O. Dignity Chatterjee of rear Post Office, Adra, PS-Adra, Dist- Purulia weighed the Cannabis (Ganja). After weighing it is found that the bag contained with 22.8 Kg Cannabis (Ganja).

Then I took three samples from the bag each contained with 100 grams Cannabis (Ganja) as sample for taking follow up action. I seized, sealed, labelled the bag containing cannabis (Ganja) and three sample packets and the bi-cycle and the weighing instruments under proper seizure list duly signed by the witnesses.

On demand the accused person could not produce any documents for the said Cannabis (Ganja). I arrested him. I briefed near the ground for which he was arrested. I also asked him whether he was willing to inform any one regarding his arrest. He replied negatively. I issued Memo of Arrest and Inspection memo. The entire search seizure and arrest was done in presence of Shri Partha Chakraborty, WBCS (Exe), DM & DC, Raghunathpur and Shri Rajesh Kanti Patra, CI Kashipur.

Now after on return to PS along with the seized articles and arrested accused person namely Ram Beuri (30 years) S/o Lt. Capt. Beuri @ Thoria of rear Chotra Hospital, Adra, PS-Adra, Dist- Purulia started Adra PS Case No-79/18 dated 16/09/18 U/S 29(b)(ii)(c) of the NDPS Act, 1985 and endorsed the case to SI Bishkekunda Ganguly for its investigation.
