In producing herewith are arrested accused person namely Rabi Bauri (30 years) S/O Lt. Gopal Bauri @ Jharia of near Chhoti Hospital, Adra, PS-Adra, Dist- Purulia and seized articles 1. One black colour luggage bag with Logo "Mitsubushi Best Quality Bag" length - 71 cm, width - 22 cm and height- 36cm, 2. Cannabis (Ganja) 22.8 kg, Marked as Exhibit "A", 3. 100 gm Cannabis (Ganja) in a brown envelope, Marked as Exhibit "A-1", 4. 100 gm Cannabis (Ganja) in a brown envelope, Marked as Exhibit "A-2", 5. 100 gm Cannabis (Ganja) in a brown envelope, Marked as Exhibit "A-3", 6. One old Bi-Cycle (Brand- KW & Model No- 800), 7. weighing instruments along with 5 kg, 1 kg, 500 g, 200g, 100g weight, 1, S. Kousik Banerjee, O/C Adra Police Station de jure logged a suo motu complaint against arrested accused person namely Rabi Bauri (30 years) S/O Lt. Gopal Bauri @ Jharia of near Chhoti Hospital, Adra, PS-Adra, Dist- Purulia to the effect that on 16.09.18 at 12:35 hrs. I get informan that the above noted accused person was coming from Raghunathpur side in Adra riding on a bi-cycle through Adra Raghunathpur Road with some contraband articles in a bag at the back side carrier of the bi-cycle. The information was duly entered in PS GD Book vide Adra PS G DE No- 542 Dd-16.09.18.

Accordingly myself along with SI Supratik Mandal, ASI 569 Parimal Tewary, C641 Chandra Parashank, C/74 Tapan Das Bora left PS with Govt. vehicle bearing No- WB58C78995 at 13:35 hrs vide Adra PS G.C. No-2822 dated 16/09/18 and Adra PS GDE No-343 dated 16/09/18 to work out the information vide Adra PS GDE No- 542 Dd-16.09.18.

At 16: 5 Hrs. we arrived near Jhanka Kali Mandir in Adra Raghunathpur Road and started writing for the said person standing at the eastern side of the said Mandir. At 16:25 hrs. we noticed that one person was coming from Raghunathpur side riding on a bi-cycle with a big luggage bag at the back side carrier of the bi-cycle. We gave signal to stop the cycle but the rider willfully ignored the signal and tried to flee away along with his bi-cycle. But however we managed to detain him after a small chase. Being asked he disclosed his identity as Rabi Bauri (30 years) S/O Lt. Gopal Bauri @ Jharia of near Chhoti Hospital, Adra, PS-Adra, Dist- Purulia. On physical verification it is found that there is one big size luggage bag at the back side carrier of the bi-cycle. From the odor of the contained of the bag it appears to be cannabis.

Informing the development to S. Susanta Kr. Patra, duty officer of Adra PS and directed him to send e-mail to the SDO, Raghunathpur to depute an Executive Magistrate to be present in P.O. during the search and also to send e-mail to CI, Kaslpur requesting him to be present during the search. Accordingly I detained the person and bi-cycle with bag and started waiting for the arrival of Executive Magistrate and C.I. Kashipur. By this time two persons namely (1) Ranjan Lewis S/O Francis Lewis of Palashkola, PS-Adra, Dist- Purulia (2) P. Sankar Chatterjee S/O Digbijoy Chatterjee of near Post Office, Adra, PS-Adra, Dist- Purulia were passing by there. I stopped them and informed the matter to them and requested them to be present there as witness during search. I then asked Palsunder Chatterjee S/O Digbijoy Chatterjee of near Post Office, Adra, PS-Adra, Dist- Purulia in writing whether he has any weighing machine or balance. If he have whether he is ready to weigh the Cannabis (Ganja). He replied in writing and brought the weighing instruments from his home at 17:30 hrs.

At 17:35 hrs. Shri Partha Chakrabarty, WBCS (Exc), IIM & DC, Raghunathpur (Deputed by SDO, Raghunathpur) as Executive Magistrate and Shri Rajat Kanti Pal, CI Kashipur arrived at the P.O. near Jhanka Kali Mandir on Raghunathpur Adra Road. Then I asked the detained person in writing to search our selves. Accordingly he searched all police persons thoroughly but found nothing objectionable. He declared this in writing.

After that we asked him that we would search him and his bag. I asked him in written whether he wanted the search to be conducted in presence of Executive Magistrate and Gazetted officer. He replied affirmatively I informed the matter to the Executive Magistrate & CI Kashi pur.

Then I started searching the person and his bag. During search I found that the bag which was at the back side carrier of the bi-cycle was packed with Cannabis (Ganja).

Then Dalazadar Chatterjee SO Diglipy Chatterjee of rear Post Office, Adra, PS-Adra, Dist-Parulih weighed the Cannabis (Ganja) After weighing it is found that the bag contained with 22.8 Kg Cannabis (Ganja).

Then I took three samples from the bag each contained with 100 gram Cannabis (Ganja) as sample for taking follow up action. I seized, sealed, labeled the bag containing cannabis (Ganja) and three sample packets and the bi-cycle and the weighing instruments under proper seizure list duly signed by the witnesses.

On demand the accused person could not produce any documents for the said Cannabis (Ganja). I arrested him. I briefed him the ground for which he was arrested. I also asked him whether he was willing to inform any one regarding his arrest. He replied negatively. I issued Memo of Arrest and Inspection memo. The entire search seizure and arrest was done in presence of Shri Partha Chakraborty, WBCS (Exe), DM & DC, Raghunathpur and S.P. Raju Kanti P., CI Kashi pur.

Now after on return to PS along with the seized articles and arrested accused person namely Bani Bouri (30 years) SO Lt. Capt. Bouri @ Thoria of rear Chakra Hospital, Adra, PS-Adra, Dist-Parulih, started Adra PS Case No-79/18 dated 16/09/18 U/S 20(b)(1)(c) of the NDPS Act, 1985 and endorsed the case to SI Bihakaranda Gogoi for its investigation.
