Rampeda Kuiry of village Ghorabandha, P.O-C.B. Sindri PS- Bagmundi, Dist- Purulia has committed theft of electricity U/S 135(1) (a) of electricity act 2003 subsequently amendment act 2007.

On 13/09/2018 at about 2:55 P.M I Sri Swapan Kumar Das, AE & Station Manager, Bagmundih CCC along with 1. Abdul Hesib, LM 2. Narayan Ch. Debnath, HC.TSH 3. — entered the premises of Sri Swapan Kuiry, S/O- Lt. Rampeda Kuiry of village Ghorabandha, P.O-C.B. Sindri PS- Bagmundi, Dist- Purulia and found Sri Swapan Kuiry was enjoying electricity unauthorizedly drawing power from the nearest L & MV line of WBSEDCL through PVC wire by means direct hooking to his house premises and connected load found 0.2 KVA. As Sri Swapan Kuiry S/O- Sri Lt. Rampeda Kuiry committed theft of electric power, So, I seized the following articles after preparing the seizer list in presence of 1. Sri Abdul Hesib, LM, WBSEDCL 2. Sri Narayan Ch. Debnath, HC.TSH The inspection team left the premises at 3:05 P.M
