I do hereby lodge complaint empowered by enabling the electricity act 2003 subsequently the amendment act 2007 to the effect that, Sri Amiruddin Ansary, S/O- Sri Ismail Ansary of village Ghorabandha, P.O- GiB Sndri PS- Bagnundi, Dist- Purulia has committed theft of electricity U/S 135(1) (a) of electricity act 2003 subsequently amendment act 2007.

On 13/09/18 at about 3:10 P.M I Sri Swapan Kumar Das, AE & Station Manager, Bagmundih CCC along with 1. Abdul Hasib, LM 2. Narayan ch. Debnath, H.C.TSH 3. — entered the premises of Sri Amiruddin Ansary, S/O- Ismail Ansary of village Ghorabandha, P.O- GiB Sndri PS- Bagnundi, Dist- Purulia and found Sri Amiruddin Ansary was enjoying electricity unauthorizedly drawing power from the nearest L & MV line of WBSEDCL through PVC wire by means direct hooking to his house premises and connected load found 0.1 KVA. As Sri Amiruddin Ansary S/O- Sri Ismail Ansary committed theft of electric power, So, I seized the following articles after preparing the seizer list in presence of 1. Sri Abdul Hasib, LM 2. Sri Narayan ch. Debnath, H.C.TSH The inspection team left the premises at 3:20 P.M.
