One three phase four-wire LTOH Line is existing within the premises of PPSP Guest house and this line is maintained by OPH wing of PPSP Site to feed power supply at Bagmundi Telephone exchange situated inside the said premises & PPSP Guest House of PPSP Site under emergency condition.

The security guard named Sri Chandi Charan Kumar on duty reported that one miscreant named Sri Buddhi Kumar of local area forcibly entered unauthorisedly in the morning into the premises of PPSP Guest house even after objection by him. Sri Buddhi Kumar tried to pluck the Amla flower from the tree existing just beside the LTOH Line by some means. During such unauthorised action by Sri Buddhi Kumar, the LTOH line snapped at two locations resulting in damage of conductors and disconnection of power supply of Bagmundi Telephone Exchange. For this WBSEDCL suffered a loss of around Rs 9000.00 (Approx.)

The report of the incident submitted by the Security Guard on duty is enclosed for ready reference.

You are requested to kindly visit the place of occurrence and give clearance for restoration of LT Power line at the earliest so that Bagmundi Telephone Exchange can be supplied with power and take necessary action as per Law against the miscreant for such unauthorised action.
