In producing herewith the accused person namely- Haradhan Saw (35yrs) @ Haru S/O- Brighuram Saw of Atna, P.S.-Baghmundi, Dist-Purulia along with seized articles 1) One yellow coloured plastic bag which containing 30 kgs Mohul, *মুহুল*, 2) Two (02) tin Akher Gur, *অখের গুড়*, 3) Two (02) Packets Nishadal having weight 01 kg each, 4) Three (03) packats of Yeast having weight 500 gm each 5) Approx 20 liters of I/D liquor in a white plastic jarican, 6) One TVS XL 100 (Heavy Duty) Motor Cycle having Chassis No-MD621EP13J1B14776 & Engine No-P8010019 which were seized under proper seizure list duly signed by the witness.

I beg to submit that today on 23/09/18 in between 07.45 hrs to 08.55 hrs a raid was conducted when I along with force were performing mobile duty at near Harupdih more area while found a person was carrying some articles which is suspected. Then I along with force was able to stop after a hot chase. On being asked the said person disclosed his identity as Haradhan Saw (35yrs) @ Haru S/O- Brighuram Saw of Atna, P.S.-Baghmundi, Dist-Purulia. On being searched found that he was carrying 1) One yellow coloured plastic bag which containing 30 kgs Mohul, *মুহুল*, 2) Two (02) tin Akher Gur, *অখের গুড়*, 3) Two (02) Packets Nishadal having weight 01 kg each, 4) Three (03) packats of Yeast having weight 500 gm each 5) Approx 20 liters of I/D liquor in a white plastic jarican, by One TVS XL 100 (Heavy Duty) Motor Cycle having Chassis No-MD621EP13J1B14776 & Engine No-P8010019 to sale those articles to someone at Tunturi village. On demand he failed to produce any valid documents in respect of carrying & selling of liquor . As such I arrested him U/S- 67 B.E. Act. and also 1) One yellow coloured plastic bag which containing 30 kgs Mohul, *মুহুল*, 2) Two (02) tin Akher Gur, *অখের গুড়*, 3) Two (02) Packets Nishadal having weight 01 kg each, 4) Three (03) packats of Yeast having weight 500 gm each 5) Approx 20 liters of I/D liquor in a white plastic jarican, 6) One TVS XL 100 (Heavy Duty) Motor Cycle having Chassis No- MD621EP13J1B14776 & Engine No-P8010019 seized under proper seizure list duly signed by the witness which is enclosed herewith. During arrest the ground of arrest was duly notified, issued arrest memo and handed over a copy of the same to the arrested person. The above noted arrested accused person namely Haradhan Saw (35yrs) @ Haru S/O- Brighuram Saw of Atna, P.S.-Baghmundi, Dist-Purulia is committed an offence U/S- 46(A)(A) B.E. Act, 1909 for unauthorized possession, carrying and sale of I/d liquor manufacturing articles with deadly poisonous Nishadal from his exclusive possession.

Under the fact and circumstances, I therefore pray that a Case U/S- 46(A)(A) of B.E. Act. 1909 may kindly be started against the said accused person namely Haradhan Saw (35yrs) @ Haru S/O- Brighuram Saw of Atna, P.S.-Baghmundi, Dist-Purulia and arrange its investigation.
